Examination-in-Chief by Ld.APP Shri. A.A. Doke:-

1. On 14.01.2023 police have called me at Arani-Pati for panchanama of spot of incident. Alongwith me another panch Alesh Waghe was present. Concern police station sent letter at our office for providing panch. Hence, my superior directed me to proceed for panchanama. Today I am not remembering the name of the person who shown the alleged spot of incident. Police have seized from the alleged spot of incident one Unicorn company two-wheeler vehicle. The said two-wheeler vehicle is having number MH-25 AE 7711. So also, police have prepared panchanama of spot of incident in presence of we panchas. The panchanama of spot of incident bear my signature and signature of another panch. As well as, seizure panchanama of two-wheeler vehicle also bear my signature and signature of another panch. The contents of said panchanamas are correct. The said panchanamas are at **Exh. P-3/P.W.2 and Exh. P-4/P.W.2.**

Learned APP submitted witness is not supporting the prosecution case and hence may be declared hostile.

2. It is true to say that, the alleged spot of incident shown by Rajabai Ghodake. On the alleged spot of incident, police have

Cross-examination by Ld. Adv Shri. R.R. Joshi for the accused:-

3. My native place is Karajkheda, Tal. Dharashiv. I am government servant in Grampanchayat in respect of supplying water. Police have called me at Arani-pati on 10.01.2023. My superior has not given written order to me for acting as a panch. The distance between village Bhandari to Karajkheda is of 08 k.m. and distance between Karajkheda to Arni-pati is of 3-4 k.m. At village Bhandari having Grampanchayat office. The panchanama of spot of incident and seizure of two-wheeler vehicle prepared between 2.30 p.m. to 03.00 p.m. But I am not remembering the exact day on which the said panchanama prepared.

4. It is true to say that, I signed on panchanama as per the say of police. It is true to say that, I do not know anything about the contents of both panchanamas. It is not true to say that, I present for panchanama without order of my senior officer. It is not true to say that, today I depose falsely.
