Deposition of witness No. 02 for Prosecution

Examination-in-chief by Shri.J.V. Deshmukh, Addl.P.P for State:

On 04-5-2023, I was posted at Local Crime Branch, Dharashiv as Police Head Constable. On 04-5-2023 while I was present at LCB along with the staff members A.P.I. Pawar, P.H.C. Shri. Pathan, L.P.C. Tele, P.N. Shri. Jadhawar, P.C. Shri. Arsewad were informed by P.S.I. Shri. Sandip Ovhal that in village Khed situated our jurisdiction a person named Munir Tamboli i.e. accused was selling prohibited gutkha in his shop named Suhana Traders. Thereafter, we staff members and A.P.I. Shri. Shailesh Pawar went to village Khed in government vehicle. There we met P.H.C. Shri. Medne of Dhoki police station and along with him and panch witnesses Garad and Gawad we went near the shop named Suhana Traders. The person in Suhana Traders saw us and fled away from there. In the presence of the panch witnesses when the raid was effected the team came across 700 packets of Badshah gutkha, 67 packets of goa gutkha, 24 packets of Rajniwas gutkha, 43 packets of Vimal gutkha, 61 packets of V-1 scented tobacco, 120 packets of XL-1 scented tobacco of Jaftani Jarda, 109 red/yellow/black packets of scented tobacco and 11 red-yellow packets of scented tobacco total

worth 2,00,803/-. Said articles were seized. When we made inquiry about absconding persona his name was revealed as Munir Bashir Tamboli. During the investigation the investigating officer has recorded my statement. The person who was absconded from the spot is present in the court today.

(Examination-in-chief completed.)

Cross-examination by Shri.P.P.Kasture, Adv. for the accused:

2. The information received by P.S.I. Shri. Ovhal was not given to Food Safety Office. It is true to say that, Food Safety Office is there in Dharashiv. P.S.I. Ovhal had received the secret information at 5.00 p.m. Before effecting raid we did not visit Dhoki Police Station. I do not have information whether P.H.C. Shri. Medane was in charge of Khed Bit or not. The registration numbers of the vehicles in which we went at the spot were MH-25/AW-7835 MH-25/AW-7856. It is true to say that, via Khed one can proceed Dhoki, Latur and Kallam. It is true to say that, road passing from village Khed is a busy road. We did not verify the shop establishment license of Suhana Traders. It is not true to say that, we did not verify the ownership of Suhana Traders. We did not verify about the ownership of the land of Suhana Traders. Apart from the accused there was no other person in the shop.

3. It is not true to say that I have deposed false that I along with the police team went at Suhana Traders in village Khed and when the person in the shop saw the police he fled away. It is true to say that, the said seized muddemal was not found in the custody of the accused. It is not true to say that I have deposed false that from the said shop we seized the muddemal worth Rs.2,00,803/- in presence of the witnesses

It is not true to say that I have deposed false that A.P.I. Shri. Pawar had prepared spot/seizure panchanama in our presence. It is not true to say that, P.S.I. Ovhal has carried out false investigation and I have given false statement to support him. It is not true to say that, I have deposed false before the Court.
