Deposition of witness No. 03 for Prosecution

I do hereby on solemn affirmation state that,

Examination-in-chief by Shri.J.V. Deshmukh, Addl.P.P for State:

In the year 2023 I was posted as P.S.I. at L.C.B., Dharashiv. On 04-5-2023, I was on duty. On that day, we received confidential that Munir Tamboli residing at village Khed was in possession of Gutkha which is ban in Maharashtra and he was selling it from his shop named Suhana Traders. We informed about the aforesaid information to in charge PI Yashwant Jadhav and I with the team consisting of API Shailesh Pawar, P.C. Shir. Janrao, P.N. Shiri. Pathan, Arsewar, Jadhwar, WPC Tele went in to government vehicle at the aforesaid spot. The entry about the same was taken in movement register. When we reached at Khed, near Z.P. School we met Dhoki police and they joined us. When we went near Suhana Traders the person there when saw us fled from there. We tried to chase him but in vain. In the presence of two panch witnesses by name Shri.Garad and Gawad we took search of shop Suhana Traders. In the search we found Vimal Gutkha, Goa Gutkha, Rajniwas pan masala, Badshah Gutkha and packets of scented tobacco worth Rs.2,00,308/-. A.P.I. Shailesh Pawar seized these articles. The seized muddemal was taken to police station

and thereafter I reported about the raid. F.I.R. now shown to me is the same. Its contents are true and correct. It bears my signature. Report is now marked as **Exh.P-1/PW-3**. Printed F.I.R. now shown to me bears my signature. It is now marked as **Exh.P-2/PW-3**. The investigation was done by A.P.I. Shri. Jagdish Raut. Thespot panchanama now shown to me was prepared in my presence by A.P.I. Shri. Shailesh Pawar. I can identify his signature. The spot panchanama bears signature of Shailesh Pawar. Spot panchanama is now marked as **Exh.P-3/PW-3. (Examination-in-chief completed.)**

Cross-examination by Shri.P.P.Kasture, Adv. for the accused:

2. With regard to the ownership of Suhana Traders no inquiry was done in my presence. In my presence no documents about the ownership of shop was collected. In my presence it is not inquired whether there was any shop establishment license of Suhana Traders. I have personally not seen the entry made in the movement register. The entry number in the movement register was 6. It is true to say that, the entry number 6 is not mentioned in the F.I.R. It is true to say that, I have stated about said entry number for first time in the Court. The panch witnesses were resident of village Khed. We had reached at village Khed at around 5.00 p.m. In the process of calling panch witnesses and giving information 15 minutes would have been lapsed.

3. It is true to say that, from village Khed there is way to Dhoki, Kallam, Murud and Latur. It is true to say that, Dharashiv-Khed road is a busy way. We came to know that the person fled from the shop was by name Munir Tamboli by Bit Ammaladar of Dhoki. I cannot state the names of shop which were adjacent to Suhana Traders. It is not true to say that I have deposed false that along with police team raid

was effected at Suhana Traders at village Khed and the aforesaid contraband articles were found. It is not true to say that I have deposed false that in my presence spot panchanama and seizure panchanama was prepared. It is not true to say that, I have lodge a false F.I.R. and I have deposed falsely before the Court today. **(Cross -examination completed.)**
