Deposition of witness No. 01 for Prosecution

I do hereby on solemn affirmation state that,

My name : Ashok Baburao Suralkar
Age : 41 yrs.
Occup. : Ward Boy, Civil Hospital, Dharashiv.
Residence : B & C Quarters, Dharashiv.

Examination-in-chief by Shri.J.V. Deshmukh, Addl.P.P. for State:

I am working in Civil Hospital, Dharashiv as Ward Boy since the year 2017. On 26-6-2022, I was on duty I was on duty at Civil Hospital, Dharashiv. On that day my duty hours were from 2.00 p.m to 8.00 p.m. on that day I was on duty at men's surgical ward.

2. On that day, a person named Vinod Jadhav i.e. the accused came in the ward in the evening by 6.30 p.m. and was calling me by my name saying ' अशक्या..अशक्या..' I told the staff nurse Raut madam about the conduct of accused. She told me to report it to Evening Super Smt. Kaurav madam. Raut madam was working with me in the men's ward. The accused had called me by my name and he scuffled with me and gave me fists and kick blows. While I was going to report about the conduct of accused to Kaurav madam, accused followed me and caught me in the stair case and again he gave me kicks and fist blows. I went in the cabin of Kaurav madam. The accused followed me in her cabin. Again, the accused gave me fists blows. I was scared because of the incident. I reported about the incident in the night at about 11.00 p.m. The F.I.R. now shown to me is recorded as per my narration. It bears my signature. Its contents are true and correct. **F.I.R.** is now marked as

Exh.P-1/PW-1. Printed F.I.R. now shown to me bears by signature. Printed F.I.R. form is now marked as **Exh.P-2/PW-1.**

3. On the next day, when police had visited the Civil Hospital, Dharashiv I had shown the spot of incidence to them.

4. With regard to the duty register the duty register extract was provided by Smt. Kaurav. The duty register extract now shown to me is the same. The **duty register extract** now marked as **Exh.P-3/PW-1.** In the said extract my name is mentioned at serial number 2. The person who had assaulted me is present in the Court today. (**Examination-in-chief completed.**)

Cross-examination by Shri. A.S.Warudkar, Adv. for the accused:

5. It is true to say that, there is attendance record of Class IV employees in the hospital. It is not true to say that, in the attendance register the staff has to sign on daily basis. (Witness volunteers that, the attendance record bears only present and absent mark and the same is maintained by the contractor.) It is true to say that, in the year 2022 the civil hospital had a main gate to the compound wall and main entrance in the building. It is true to say that, there was security guard at the main entrance of the building of hospital. It is not true to say that, in the year 2022 at the entrance of the civil hospital building there was a police chowki. It is true to say that, at the civil hospital police constables are on duty 24 x 7. The men's surgical ward was on the 3rd floor of the building. It is true to say that, in the ward there are peons who make inquiry with the patient and their relatives.

6. It is true to say that, the accused was not admitted in our ward so also his relatives were not admitted in the said hospital. It is true to say that, the accused did not have any occasion to observe my

work. It is true to say that, if any person comes in the hospital then the security guard or the peons asks him the purpose of his visit. It is true to say that, if there is attack by fist and blows the security guard comes over there. (Witness volunteers that, when he was assaulted by the accused, the security guards were at the ground floor.) It is true to say that, if any person creates ruckus in hospital the security guard or staff will prohibit such person from exiting the hospital. It is not true to say that, in the year 2022 there were CCTV cameras installed in the civil hospital. It is true to say that, CCTV camera was only available at the main entrance of the hospital.

7. It is true to say that, Raut madam and Kaurav madam were my colleagues on daily basis. It is true to say that, I did not report about the incident to the police in the hospital immediately after the incident. It is not true to say that, I have lodged false F.I.R. against the accused. It is true to say that, in the surgical ward there is always rush. It is true to say that, in the mob the relatives of the patients be always there. It is not true to say that I have deposed false that on 26-6-2022 I was on duty. It is not true to say that I have deposed false that the accused had given me kicks and blows in the ward as well as in the cabin of Kaurav madam. It is not true to say that, I have deposed false before the Court today. **(Cross -examination completed.)**
