6.Particulars of offence :-

That, on 04.02.2024 at about 2.45 p.m. at Savargaon to Suratgaon road, Tq. Tuljapur, Dist. Dharashiv, you drove vehicle i.e. Goods Carrier of Eicher company made bearing registration No. MH-13-DQ-2763 in a rash or negligent manner so as to endanger human life or to be likely to cause hurt or injury to any other person & thereby committed an offence punishable **U/sec. 279 of the Indian Penal Code** and within my cognizance.

Secondly, on the above said date, time and place, you accused caused hurt to the informant and his friend Hemant Sanjay Kumbhar by driving above said vehicle so rashly or negligently so as to endanger human life or the personal safety of others and thereby committed an offence punishable **U/sec. 337 of the Indian Penal Code** and within my cognizance.

Thirdly, on the above said date, time and place, you accused caused grievous hurt to the informant and his friend Hemant Sanjay Kumbhar by driving above said vehicle so rashly or negligently as to endanger human life or the personal safety of others and thereby committed an offence punishable **U/sec. 338 of the Indian Penal Code** , and within my cognizance.

Fourthly, on the above said date, time and place, you drove the above said vehicle in a rash or negligent manner and caused death of Hemant Sanjay Kumbhar, not amounting to culpable homicide and thereby committed an offence punishable **U/s. 304 (a) of the Indian Penal Code** and within my cognizance.

Lastly, on the above said date, time and place, you accused found driving above said vehicle in rash or negligent manner and gave dash to the motorcycle bearing registration No. MH 13-BM-9926 and you have not provided medical aid to the injured persons and failed to inform to the nearest police station about the said accident and thereby committed an offence punishable **U/sec. 134 (a) & (b) of the Motor Vehicles Act** and within my cognizance.
