EXAMINATION IN CHIEF BY APP Ghodke

1. Swati was my sister. Her marriage was performed 8 years ago. She was given to Rajendra Maruti Lale in Koral. After marriage, she went to her matrimonial house. Her mother in law and husband was residing in matrimonial house. Her in laws was harassing her on account of giving less Hunda, not giving money. They wanted to establish big tailor shop, therore they sent my sister to the village to bring money. She used to state to us illtreatment caused to her. We sent her back by making her understand at two to three times. We sold our field, they sent my sister to bring money, came from selling field. We sent her by giving Rs.1,50,000/-. After some days, my grand father informed by making phone call that she died. We went to Koral. We went there and saw, she hanged herself. We went and saw that there was assault mark on her body. There was continuous harassment to her from her in laws. Afer we went there, police has taken body down and sent to post-mortem. On that day, there was no time to give FIR., we were busy in her last rituals, therefore on the next day FIR is given. On the next day, FIR is given in Murum police station. I narrated all the things to police, by going to police station. Police issued F.I.R. Now, report is shown to me. It bears my signature. Its contents are true and correct. It is marked at **Exh.P-30**.

2. I came in the court of learned JMFC. There Madam has asked about the happened incident, we state it. Statement now shown to me.

It bears my signature. Contents are true and correct. It is marked at **Exh.P-31.**

3. Mother in law and husband of my sister who caused harassment to her is present in the court today.

4. My education is Diploma. It is done at Akkalkot. My 11th and 12th did take place at Solapur, at that time I was in Solapur. For diploma I was in village. There is no college of diploma in my village. Diploma college is at Akkalkot. College hours is 9:00 to 5:00. I come home at 6:00 pm. Due to which, during this period what happened in the house, whose phone call comes, I do not know. There is minor altercation between me and my father. It is not true due to it, I have no talks with my father. It is not true there is always quarrels in the house in between my father and mother. It is not true my sister before marriage being frustrated due to quarrel of father and mother consumed pesticide. My father, relatives have fixed marriage of my sister with Rajendra after verifying that Rajendra is having field, 50 sheep, goats, tailoring shop, travelling agency. Father of Rajendra used to go to the field by taking sheeps, goats at 9:00 am. It is not true mother of Rajendra used to go to field in the morning and comes in the evening. Rajendra used to go to tailoring shop in morning, to this question witness says shop was situated in the house. Rajendra does not have travelling booking shop at Murum Mod. It is not true my sister used to do household work alone after going of Rajendra, his parents from the house. It is not true, accused used to meet with my sister only in the evening. It is true, after marriage, accused again purchased five acre land. It is true their financial condition was sound. It is not true I was not knowing personally about the harassment caused by accused to my sister on account of hunda, money. It is not true, since marriage only at two times, I had gone to the house of my sister. It is true, meanwhile my sister conceived, I brought her in village for delivery. It is not

true three to four days prior to the delivery, my sister quarrelled with the parents and went back to accused at Koral, accused admitted her in the hospital at Omerga.

5. I am unable to state day and date on which accused sent her back to bring money. Can you state day and date of causing harassment to your sister, to this question witness says I am unable to state. I could not state day and date of sending back my sister to the house of accused, by making her understand. Complaint was given to the President of village Tanta Mukti Committee in respect of harassment to my sister. I could not file copy of said complaint. I have taken my sister to give consent to sell field when nobody was in the house at Koral. On which date and day, Rs.1,50,000/- given could not be stated by me. Cash of Rs.1,50,000/- was given. I could not state description, denomination of currency notes.

6. On the day of incident, on the spot of incident, what happened, you do not know about it personally, after receiving phone call, you learnt about it to this question, witness says, after receiving phone call learnt about it. It is not true my parents did not want to give report of the incident, Dada Ghodke of Supat village accompanied them to give report. It is not true after the death of my sister, I, relatives, my parents, we all thought collectively to give report. I, father and maternal uncle have gone to give report. It is not true as I was of younger age, having less information about incident, therefore, my father, my maternal uncle stated contents in the report. It is not true contents in report is typed by police, it was not read over to me, I put my signature.

7. I did not state to police while giving report that there was assault marks on the body of my sister. It is not true that, contents in Exh.30, in my examination in chief is false one.

8. I received summons from the earlier court. It did happen that police called me to come in court. Police had written one paper and it

was given to me for reading. It is not true that police asked me to state same contents read by me, in court. It is not true I stated in consonance with the paper given by police, read by me. It is not true I stated contents in Exh.31 on the say of police. It is not true I deposed falsely. It is not true contents in examination in chief is false one.
