EXAMINATION IN CHIEF BY AGP.Deshpande

1. Victim is my sister. My father was working at Rajapur Depo Dist. Ratnagiri as driver. Incident happened on 2.12.2020. On that day at about 10:00 am, I and my mother had gone towards field by taking buffallow. At 12:00 pm, mother has sent me to Sastur for marketing. I came in village, from village I went to Sastur market in tum-tum. By going to Sastur, I purchased articles asked by mother and returned village at 3:00 pm. I came home, my sister was doing swipping work, I kept bag of the articles, and I again went to field. Thereafter, at 6:00 pm, I alongwith my mother returned to home. Mother was tying buffallows, I opened door and went inside the house. I saw my sister Aanksha was lying in front of the TV. Blood was oozing from her left hand. Bottle of the Gochid medicine was lying besides her. I shouted. After I shouting, mother came inside the house, after tying buffallows. Mother made phone to call to father. My father made phone call to uncle Anil Survase. Anil Survcase called rickshaw driver of the village. In said rickshaw my sister was sent to hospital. In said rickshaw I, my mother alongwith sister had been to the hospital. Uncle Anil Survase was also alongwith us in rickshaw. At Sastur, Dr. gave initially stitches on the hand of my sister. Dr. informed police and called police. Police has recorded statement of my sister Aankasha when she gain her consciousness. In statement of my sister , she stated that since last two days phone call was

coming from unknown number, therefore she consumed insecticides and by cutting the vein , she attempted to commit suicide. Doctor has referred my sister to Latur for further treatment. My uncle and mother accompanied sister to Latur, I returned home in tum-tum. Police make inquiry with me, recorded my statement.

2. I went towards the field, at that time, my sister was normal, her mental condition was good. I returned home from market at 3:00 pm, at that time my sister was in normal condition. Education of my sister was going very well.

3. I did not state to police father made phone call to uncle. I did not state since last two days phone call was coming from unknown number. It is not true I gave statement to police on the say of my parents and today deposed in Court on their say. Dr. has taken my sister inside for medical treatment at that time, I and my mother were sitting outside. It is not true entire statement in examination in chief is false one.
