CROSS EXAM FOR ACCUSED BY ADV. JADHAV

3. Naichakur PHC Hospital is available for the villages such as Bhagatwadi, Naichakur, Kolewadi and other villages. Said PHC is situated adjacent to the village, adjacent to Naichakur, Shirsi road. At the west side of hospital, our residential old and new quarters are situated. Distance from Hospital to our residential quarters is 100 to 150 feet. All employees, Doctor of the PHC reside in old and new quarters. Hospital door is facing southern side, OPD of the hospital is situated at the north side. Patient requires to come inside the hospital from the southern side main door of the hospital.

4. I worked as watchman in Naichakur PHC for five years. Witness says from 2010 to 2015. My education is 9th Std. I can read and write. Duty of the Government servant watchman is of eight hours. I have to maintain register being in the capacity of watchman. In night patient, his relatives came whether entry of this is taken in register, to this question witness says no such register is maintained. Inquiry is to be made with the patient, relatives come in the hospital.

5. Naichakur village is a big village. At the time of incident, brother of the accused Namdev Delip Pawar was the respectable person of said village and sarpanch. Being in the capacity of sarpanch, he has control over the basic needs, water provided to the hospital. Sarpanch is looking after facility provided to the patient, his relatives to stay in the hospital. People gave oral complaint to the sarpanch that proper medical treatment at the proper time is not provided in the hospital, doctors are not present in the hospital. Before alleged incident, sarpanch came in the hospital to make inquiry in respect of said complaint with the medical officer, employees at that time there was dispute in between sarpanch and medical officer, employees of the hospital.

6. I have to obey work stated to me by medical officer, his superior/senior officer. It is true due to dispute in between Namdev Pawar, medical officer and employee of our hospital, there was enmity in the mind of employees, medical officer of the hospital.

7. Distance from Naichakur to Omerga is around 25 kilometer. After the incident, I , employees of the hospital have not informed medical officer, because medical officer was not present there, he came on the next day. Complaint application was given to the police station on 24/8 at 8:00 am. On the next day by asking to the medical officer, employees written application is given. After giving report, I did not meet with police. Maherabee Govind Pawar, Mangalbai Mahadev Kamble were working as sister in the hospital, Shivaji Shankar Sanatan, Pramod Mahadev Bondar were supervising in the hospital. These employees and I reside in the same area in quarters. As we all were working in the same hospital, residing in the same area, therefore we were helping each other in the case of need.

8. It is true that it is not visible during the night time, day time what is going on in the hospital from the quarters.

9. Sharad Pawar came in the hospital, he gave abuses and pushed, this incident lasted for 30 to 45 minutes. In said incident , my shirt torned, Police have not seized my torned shirt. It is not true I deposed falsely that on that day, I had night duty, at 12:30 am , Sharad Delip Pawar came there by coming he quarreled with me, he asked me where is the patient, there was no patient, he asked where is the sister, called this sister, call that sister, he dragged me out of PHC. Trimbak Dabde and his son Sachin Trimbak Dabade came and they rescued.

10. I stated to police while giving report by coming he quarreled with me, he asked me where is the patient, there was no patient, he asked where is the sister, call this sister, called that sister. I stated while giving report that thereafter two people of the village came,those people rescued,

villagers have taken Sharad Pawar in the house, at that time, I was doing official duty, he caused obstruction in my official work.

11. It is not true that Sharad Pawar has not pushed me, not gave abuses to me, not caused obstruction in my official work. It is not true that medical officer, employees with the help of me have given false report against accused by keeping in mind their dispute with the then sarpanch Namdev Pawar, brother of the accused, to teach him the lesson. It is not true today I deposed falsely.
