CHARGE WITH FOUR HEADS
(No. XXVIII (II), schedule v, act v, 1898)
(Sections 221, 222, 223, Code of Criminal Procedure)

(1) Name and office of Magistrate & I (1) Shri Indranil Chatterjee, (WB00827),
1st Assistant Sessions Judge, Baruipur, Dist South 24 Parganas

(2) Name of accused hereby charge you, **1) Bhim Sardar, 2) Bikash Sardar, 3) Arjun Sardar, 4) Nakul Sardar, 5) Ranjan Sardar and 6) Uttam Mondal.**

as follows : -

Firstly - That all of you in execution of your common intention, on 01.03.2018 at about 08.30 p.m. at Bantra, under Police Station Joynagar committed criminal trespass into the house of the de facto complainant with an intention to commit criminal offence and thereby, you committed an offence punishable under Section **447/34** of the Indian Penal Code and within (3) the cognizance of the court of Sessions.

Secondly - That all of you in execution of your common intention, on 01.03.2018 at about 08.30 p.m. at Bantra, under Police Station Joynagar voluntarily caused grievous hurt to the de facto complainant Bapi Gharami and his family members, by sharp cutting weapon being blade at the chest and back side of their heads and further assaulted them with iron rod at the chest and heads for which they received bleeding injury and thereby, you committed an offence punishable under Section **325/34** of the Indian Penal Code and within (3) the cognizance of the court of Sessions.

Thirdly - That all of you in execution of your common intention, on 01.03.2018 at about 08.30 p.m. at Bantra, under Police Station Joynagar, did an act of assaulting the de facto complainant namely, Bapi Gharami and his family members, by sharp cutting weapon being blade at the back side of their bodies and heads causing grievous injury with such intention and under such circumstances that if by that act you had caused death of the de facto complainant and his family members, you would have been guilty of culpable homicide not amounting to murder and thereby, you committed an offence punishable under Section **308/34** of the Indian Penal Code and within (3) the cognizance of the court of Sessions.

Fourthly - That all of you in execution of your common intention, on 01.03.2018 at about 08.30 p.m. at Bantra, under Police Station Joynagar committed criminal intimidation by threatening the de facto complainant with injury to his person with intent to cause alarm to him and thereby, you committed an offence punishable under Section **506/34** of the Indian Penal Code and within (3) the cognizance of the court of Sessions.

(3) New Cognizance or cognizance of the Court of Sessions
(4) In cases tried by Magistrates omit "by the said Court"

And I, hereby direct that you be tried (4) by this Court on the said charge.

The contents of the charge is read over and explained to the accused in Bengali and being asked, he pleads not guilty and claims to be tried.
