

DEPOSITION OF WITNESS NO.8 FOR PROSECUTION

I do hereby state on solemn affirmation that :-

My name is :- Sudhakar Dnyanoba Birajdar

Examination-in-chief-By Ld. APP Shri. Ayojudin Riyajudin -

1. In the year 2023 I was working as Medical Officer at P.H.C., Yermala. On 06/04/2023 I examined Babasaheb Prakash Mahajan and Samarth Babasaheb Mahajan. Those patients were referred to me by Police Station, Yermala.

2. I examined Babasaheb Prakash Mahajan and found total two injuries on his person which are as follows :

a) CLW over left parietal bone. Size of injury was 4x1 cm. Age of injury was within 02 hrs. The injury was caused by hard object. The nature of injury was grievous.

b) CLW over left left elbow joint. Size of injury was 4x4 cm. Age of injury was within 02 hrs. The injury was caused by hard object. The nature of injury was grievous.

3. Thereafter, I referred Balasaheb Mahajan to Civil Hospital, Dharashiv for CT-scan and X-ray elbow. As per Civil Hospital record CT-brain of the said patient was carried out. As per that report there was soft tissue swelling over right temporal region of the brain and haematoma of size 24 mm x 13 mm was found in the brain.

4. As per X-ray report there is fracture of left ulna upper third shaft. Hence, the nature of the injury is grievous.

5. On that day I examined Samarth Babasaheb Mahajan and found one injury on his person which is as follows :

a) CLW over mid parietal bone of scalp. Size of injury was 3x1.5 cm. Age of injury was within 02 hrs. The injury was caused by hard object. The nature of injury was simple.

6. Thereafter I issued Medical certificate on the basis of examination. Now, I am shown those medical certificates. It's contents are true and correct. It bears my signatures. It be marked as **Exh.37 for Babasaheb and 38 for Samarth** respectively.

7. The above mentioned injuries are be possible by stick वस्तु झ/१ ते झ/४.

Examination-in-chief is completed.

8. It is true to say that, aforesaid injuries are possible if the person slips from motorcycle. It is true to say that, being expert witness I mention age of injury as per history narrated by the patient. It is true to say that, I did not mentioned the name of the concern police personal who referred patient to me. Witness deposes that, column regarding name of police station, brought by and P.C. number are blank.

9. Firstly I examined Babasaheb for five minutes. It is true to say that, the completion of time is not mentioned in the Exh. No.37 and 38. It is true to say that, Exh.37 & 38 bears the same time of examination.

10. It is not true to say that, I deposed nature and description of injuries on the basis of incomplete information. It is true to say that, Babasaheb and Samarth are not present in Court today. It is not true to say that, I am deposing false.
