5. **Particulars of the offence complained against the accused are read over to him as follows :**

That, on 02/01/2020 at about 05.00 a.m., near Kanheri Pati, at NH-52, Kanheri, Tq. Washi, Dist. Dharashiv, you accused drove your Jeep No. MH-26-BC-0945 in a manner so rash or negligent as to endanger human life or to be likely to cause hurt or injury to any other person and gave dash to complainant's brother namely Rajendra Jagatap and thereby committed an offence punishable under section 279

of I.P.C., and within my cognizance.

That, on the same date, time and place, you accused caused simple hurts to the complainant's brother by driving your Jeep No. MH-26-BC-0945 so rashly or negligently as to endanger human life or the personal safety of others and gave dash to complainant's brother namely Rajendra Jagatap and thereby committed an offence punishable under section 337 of I.P.C., and within my cognizance.

That, on the same date, time and place, you accused caused grievous hurts to complainant's brother by driving your Jeep No. MH-26-BC-0945 so rashly or negligently as to endanger human life or the personal safety of others and dashed to complainant's brother namely Rajendra Jagatap and thereby committed an offence punishable under section 338 of I.P.C., and within my cognizance.

That, on the same date, time and place you accused, drove your Jeep No. MH-26-BC-0945 on a public way in a manner so rash or negligent without seeing the traffic condition and circumstances of the road and thereby committed an offence punishable under section 184 of Motor Vehicles Act, 1988 and within my cognizance.

That on the aforesaid date, time and place, you did not take any step to secure medical treatment for the injured by conveying him to the nearest medical practitioner or hospital and you did not report the circumstances of the

occurrence at the nearest police station and thereby committed an offence punishable under section 134 (a)(b) of Motor Vehicles Act,1988 and within my cognizance.
