BP No. 262/2026 has been filed and moved for accused/petitioner :- Krish Singh @ Ayush Singh, S/o Sanjay Singh @ Sanjay Kumar BP No. 366/2026 has been filed and moved for accused/petitioner :- Md. Nazim, S/o Hakimuddin Both In C/w Hunterganj PS Case No. 206/2025, U/s 308(4), 111(3), 111(4) of BNS Present FIR was lodged by one Premchand Singh that from WhatsApp No. 971545920432, call came demanding levy – extortion money of Rs. 02 Crore, allegedly by one Prince Khan, from Dubai. In course of investigation, name of present accused persons transpired from confessional statement of co-accused. Accordingly they were remanded into this case and since 20.04.2026 – More than 03 months and since 10.06.2026 - a little less than 02 months. they are in Judicial custody. Case has already been charge sheeted against present petitioners. Petitioner of BP No. 262/2026 – has two Criminal antecedents. Petitioner of BP No. 366/2026 – has one Criminal antecedent. By filing BPs, it has been alleged interalia that they are quite innocent and have falsely been implicated in this case. They are not named in FIR. FIR story is false and fabricated. Nothing incriminating was recovered from their possession. Alleged sections are not attracted

	Contd P/2 05.08.2026	against them. They are in Judicial custody since 20.04.2026 & 10.06.2026. Lastly prayed for bail. Learned PP opposed the prayer. Case diary and TCR received. Heard, perused and considered. Alleged WhatsApp number does not belong to present accused persons/petitioners. There is no recovery from the accused persons/petitioners nor named in the FIR. They are in Judicial custody since 20.04.2026 & 10.06.2026. Co-accused was granted bail by this court vide BP No. 184/2026 upon similar/lesser detention. Considering all above, I am inclined to admit the accused persons/petitioners into bail. Accordingly, prayer for bail of accused persons/petitioners named above, stands Allowed.
