10. Now declaration of subsection 5 (1) executed by the borrower shown to me. It bears signature/thumb impression of borrower. Its contents are true and correct. It is marked at Exh. 18.

11. The office copy of legal notice issued to borrower dated 08/03/2023 shown to me. It bears signature of advocate of bank. Its contents are true and correct. It is marked at Exh. 19. The said notice issued through RPAD postal receipt is shown to me. It is marked at Exh. 20 and 22. Acknowledgment receipt of the notice is at Exh.21. It bears signature of Suresh Humbe.
