The suit is for recovery of money of Rs.47,389/- from the defendants with subsequent compound interest at the rate of 15.30 % per annum and for costs.

Value of claim for recovery of money of Rs.47,389/- and court fee of Rs.1,422/- paid Under Order 22 of TNCF & SV Act.

Cause of action for the suit arose on 21.08.2018, 10.08.2021, 22.03.2023 at Chidambaram.

Plaint first presented before this court on 03.03.2026.

This suit has been taken on file on 03.03.2026 and came before me for final hearing on 17.07.2026 in the presence of Learned Advocate Thiru.S.Jagadhathri, for Plaintiff, Defendants were called absent and Set Exparte and after verifying the documents and having stood over for the consideration of this court till this date, this court delivers the following,

DECREE

(i) That the defendants are directed to pay the plaintiff a sum of Rs.47,389/-

(ii) That the defendants are further directed to pay the subsequent interest at 9% per annum on the principal amount Rs.50,000/- from the date of filing of the suit till the date of decree,

(iii) That the defendants are directed to pay the subsequent interest at the rate of 6% per annum on the principal amount Rs.50,000/- from the date of decree to the date of realization,

(iv) That the defendants are directed to pay a sum of Rs.1,432/- to the Plaintiff.

(v) That the Decree amount, together with interest and cost awarded herein, shall be paid by the Defendants within a period of three months from the date of receipt of this judgment.
