Heard. Perused the papers. Out of the total deposited amount of **Rs.23,19,926/-** (Rupees Twenty three lakh Nineteen thousand Nine hundred twenty six only) the deduction of court fee, fix deposits and payments are as under:-

Rs.7,500/-	Be recovered towards deficit Court Fee and credited into Govt. Treasury.
Rs.11,33,090/- Rs.1,61,869/-	Be invested in FIXED DEPOSIT RECEIPT for a period of FIVE YEARS , as under in the name of: Legal Heirs of deceased Thakor Ajmalji Keshaji (1) THAKOR ASHABEN WD/O AJMALJI (4) THAKOR HIRABEN KESHAJI All are residing at Thakor vas, Dedarda, Taluka- Becharaji, District- Mahesana.
Rs.2,31,242/- Rs.2,31,242/-	Be invested in FIXED DEPOSIT RECEIPT for a period of Five Years or till the minors attain the age of majority whichever be later in the name of: (2) MINOR- THAKOR DIVYA D/O AJMALJI (3) MINOR- THAKOR KEVINJI S/O AJMALJI (Applicant No.1 is mother, guardian of minor applicant Nos.2 & 3.) FD shall be invested in any Nationalized Bank with a direction to the Bank not to flow any loan or not to create encumbrance etc. on the amount invested in the Fixed Deposit without prior permission of this Tribunal. However, respective claimants shall be entitled to withdraw the interest periodical accruing on such Fixed Deposit. The concerned Bank is also directed to release the said amount to each applicants, invested in the Fixed Deposit on the date of its maturity, without requiring any further orders from this Tribunal.
