ORDER BELOW EXH. 1

1) This is the application filed by the applicant for issuing search warrant for search of minor grand daughter namely Inaya Imran Mulani, age 12 years and minor Grand Son Namely Imar Imran Mulani Age – 6 years. It is the contention of the applicant that the persons to be searched are children of his deceased daughter Shaguft Imran Mulani and deceased Imran Mehemud Mulani. After death of daughter and son in law he is taking care of his grand daughter and grand son. Non-applicant no. 1 Nilofar Imran Mulani is step-mother of his grand children. Other non-applicants are related to her. Grand children of the applicant were residing with him after death of their parents. On dated 04.04.2026 applicant with his grand children was went at Velapur, Pandharpur for performing religious rites of his son-in-law. The non-applicant said him to keep his grand children with non-applicant no. 1 for 4-8 days, therefore applicant left his grand children at Velapur. Thereafter applicant went to Velapur for bringing his grand children but the non-applicants even not allowed to contact him to his grand children. It is contention of the applicant that, the non-applicant have illegally confined his grand children, therefore he filed this application for issuing search warrant of his grand children.

3) In the present matter the parents of the minor Inaya and Imar are died, and therefore, the applicant being their nearest grand father has right to custody of his minor grand children, issues of his deceased daughter. The non-applicants has no rights to keep minor Inaya and Imar in their custody and confined against the will of their grand father. Confining and keeping in their custody to minor Inaya and Imar by non-applicants against the will of applicant is an

offence. So also, this court has jurisdiction under section 100 of B.N.S.S. to issue search warrant for search beyond jurisdiction. Considering facts and circumstances I am incline to pass following order.

ORDER

- 1) Issue search warrant to Police Station Officer, Police Station Pandharpur Tq. Pandharpur Dist. Solapur for search of minor Inaya Imran Mulani and Imar Imran Mulani at the house of non-applicants at Velapur Tq. Pandharpur Dist. Solapur or at any other place as shown by the applicant, as where is possibility of availability of the minor Inaya and Imar.
- 2) The Police Station Officer, Pandharpur to search the minor Inaya Imran Mulani and Imar Imran Mulani and produce them before the court.
- 3) The Police Station Officer, Police Station, Paranda to provide necessary help to the applicant for search of his grand children by receiving necessary police assistance charges.
