I do here state on oath as under :

Examination in chief by Shri. V.S.Gaikwad APP for the State.

1) I am educated up to M.B.B.S., M.D. in anaesthesia. Since 2006 I am working as Medical Officer. On 18/08/2021 I was working as Medical Officer at Sub District Hospital Paranda as Medical Officer. On that day I was on call Medical Officer. On that day patient namely Sarika Amol Bansode was came for medical examination, she was send by police with letter. She had given history of physical assault by relative. I examine her and found :-

1. Contused lacerated wound on forehead in between eyebrows, size of injury measuring 2.5 x 1.5 x 0.5 cm.
2. Contusion over left arm posterior aspect, measuring 4 x 2.5 C.M.,
3. Contusion over back in two numbers, each measuring 6x 2.5 C.M.
4. Abrasion over right hand palm measuring 2 x 3 C.M.,

All the injuries were caused by hard and blunt object, age of injury within 1 to 2 hours, injury is fresh. Nature of injury was simple.

I examine the patient at about 08.00 p.m. I mentioned identification mark of patient as mole on right side of chest. As per the examination I taken entries in MLC register. I have brought MLC register. MLC register

bears thumb impression of patient. All injuries are possible if beaten by bamboo stick. After examination of the patient I issued certificate. I issued certificate as per examination of the patient as per original MLC register. The said certificate is now shown to me. It bears my signature. The contents of it are true and correct. It is Exh. 40.

Cross Examination by Advocate A.D.Kharsade for the accused.

Injuries might have been caused at 06.00 p.m. It is true to say that there is a correction in the date of examination of the patient in certificate Exh. 40. Certificate bears also the date of examination as 18-08-2021. All injuries mentioned in certificate Exh. 40 are possible by falling from a running motorcycle. It is not true to say that I have issued certificate as per the say of patient and I have issued a false certificate. It is true to say that it is not mentioned in certificate that injury no. 4 is caused on palm. I personally do not know Sarika Bansode.
