I do here state on oath as under :

My age : 42 years, Occ.: Privat Medical.

Examination in chief by Shri. V.S.Gaikwad APP for the State.

1) I am educated up to M.S. Orthopedic. Since 13 to 14 years I am working as Medical Officer. My hospital name is Krushna Orthopedic Hospital. I am running it since last 9 to 10 years. On 27-08-2022 I was present in my hospital. On that day patient namely Mahadeo Maruti Shinde was came for treatment with history of physical assault dated 26-08-2022 by know person. I admitted him to hospital. I examine him and found :-

1. Pain and swelling to right forearm.

I taken the X-ray right hand wrist forearm. I found left distal 1/3 ulna fracture. Nature of injury was grievous, it was cause within 24 hours and was caused by heavy and blunt object. Accordingly I issued medical certificate. The said certificate is now shown to me. It bears my seal and signature. The contents of it are true and correct. It is Exh. 36. Medical certificate was collected by police station Officer Paranda. Police Station Officer Paranda had given letter for issuing medical certificate accordingly I issued. Now letter given by police to me, is shown to me it bears my endorsement as received. It is mark at Exh. 37. After admission

of the patient in hospital I inform Barshi City Police by giving letter. Now letter is shown to me it bears my signature and seal of the hospital. Its contents are true. It is mark at Exh. 38. Police had recorded statement of the injured before me at my hospital. The injury mentioned in certificate Exh. 36 is possible by stick Article A's blow. I have brought case paper and MLC register.

Cross Examination by Advocate Z.I.Chaudhari for the accused.

Now OPD time of my hospital is 11-00 a.m. to 07.30 p.m. Due to non availability of Orthopedic Surgeon at Paranda many peoples came at Barshi for treatment. The patient was came at my hospital at 05.00 p.m. It is true to say that time of examination of the patient is not mentioned in certificate Exh. 36, column of police station is also blank. It is true to say that history of assault is not mentioned in certificate. Time of injury is mentioned by me as per the say of patient. It is true to say that, as the patient had not external injury it was not possible to mention exact time of injury. It is true to say that identification mark of patient is not mentioned in certificate Exh. 36. It is true to say that, injury mentioned in certificate Exh. 36 is possible by falling on hard and tuff surface by slip. It is true to say that, period of admission and discharge of the patient is not mentioned in certificate. It is not true to say that, as the injured is my regular patient, I issued false certificate according to his say. It is not true to say that, I depose falsely.
