JUDGMENT

The accused above named has been forwarded by the police
of PS Tanda, District, Hoshiarpur, for facing trial in above noted case.

2. The brief facts of the prosecution case are that on 1-4-2020 at
about 6 PM in the area of PS Tanda, District Hoshiarpur, the accused has
violated the order Endst No.3513/MC3/MA dated 23-3-2020 which was
promulgated by the District Magistrate where under the general public
was abstained from opening the shops due to COVID -19, but the accused
violated the said orders by opening General Store and the accused
malignantly did an act which he knew or had reasons to believe to be
likely to spread affection to coronavirus disease dangerous to life and
further the accused has disobeyed the quarantine rule made or
promulgated by the Government.

On the basis of the violation made by the accused, he was booked
in this case. He was arrested and was released on bail. Investigation was

initiated. During the course of investigation, statements of witnesses were recorded. After completion of investigation and other formalities, challan against the accused was presented in court.

3. On presentation of challan, copies of challan along with other documents were supplied to the accused free of costs. After finding prima-facie offence U/S 188,269,270 & 271 IPC, charge against accused was framed accordingly, to which accused pleaded guilty and did not claim trial.

4. On the basis of the plea of the accused regarding admission of guilt and that he opted not to claim trial, and considering the fact that the plea made by the accused is made voluntarily, the accused is held guilty for the offence punishable U/S 188,269,270 & 271 of the IPC and convicted for the same. Let the accused be taken into custody and be heard on quantum of sentence.
