ORDER BELOW EXHIBIT NO. 01 IN
CRIMINAL BAIL APPLICATION NO. 445/2026

Sahdev Chavan and others Vs. State

[Passed on 16th June , 2026]

01. Accused – applicant No.1 Sahdev Ganpatrao Chavan, No. 2 Ratnamala Sahdev Chavan and No. 3 Surekha W/o. Ankush Chavan have filed the application under Section 482 of Bhartiya Nagarik Suraksha Sanhita, 2023 for granting them anticipatory bail in connection with Cr.No.145/2026 registered at Police Station Tadkalas, Tq. Purna, Dist. Parbhani for offence punishable under Sections 118(1), 115(2), 351, 352, 85 r.w.Sec. 3(5) of Bhartiya Nyaya Sanhita, 2023.

02. The prosecution case, in short, is that, informant PDC in civil hospital Parbhani made statement before police on 28.05.2026 alleging that she married on 12.05.2019. She has three daughters. Her husband is owner and driver of Eicher truck. It has alleged that on 23.05.2026 her husband on the instigation of his mother and sister assaulted to the informant by iron rod on her back and leg on the ground that she has not given birth to son. Her mother-in-law abused her and gave threat to kill her. Her sister-in-law on phone call instigated to her mother-in-law. Her father-in-law unnecessarily on the say of her mother-in-law used to abuse her.

03. On the report the aforesaid crime came to be registered against the accused for the aforesaid offences.

04. It is the contention of the accused-applicants that, they have not committed the alleged crime. These accused-applicants have not assaulted to the informant. The allegations against them are that they abused to the informant. The offence is not punishable for more than three years imprisonment. They are ready to assist I.O. They prayed to release them on regular bail.

05. Ld. APP in his say Exh. 6 has submitted that these accused-applicants have instigated to the husband of the informant. Investigation is to be made. If the accused are released they will pressurize to the informant. He prayed to reject the application.

06. I have heard Ld. Adv. Mr. S.A. Bagal for the accused and Ld. PP Mr. D.U. Darade for the State.

07. Perused the record. Ld. APP has submitted that the application may be allowed. The offences levelled against these accused are not punishable for more than three years imprisonment. Nothing is to be recovered from the accused. Therefore personal liberty of the accused needs to be protected. Hence, I pass the following order.

Order

1	The application is allowed.
2	In the event of arrest of applicant-accused No.1 Sahdev Ganpatrao Chavan, No. 2 Ratnamala Sahdev Chavan and

	No. 3 Surekha W/o. Ankush Chavan they shall be released on P.B. of Rs.25,000/- each and surety in the like amount in connection with Cr.No.145/2026 registered at Police Station Tadkalas, Tq. Purna, Dist. Parbhani for offence punishable under Sections 118(1), 115(2), 351, 352, 85 r.w.Sec. 3(5) of Bhartiya Nyaya Sanhita, 2023, with condition that-
	1) They shall attend the concern police station during 10.00 a.m. to 01.00 p.m. on every Sunday for one month if called by I.O.
	2) They shall assist the investigating officer for investigation.
	3) They shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade them from disclosing such facts to the Court or to any police officer.
	4) They shall not hamper or tamper with the prosecution evidence.
	5) They shall not go abroad without permission of the investigating officer, till filing charge-sheet.
3	Inform to concern police station accordingly.
