The applicant has sought the relief of bail under
Section 483 of the Bhartiya Nagarik Suraksha Sanhita, 2023

in connection with Crime No.285/2026, registered in Police Station Selu for the offenses punishable under Sections 123, 223, 274, 275, 3(5) of the Bhartiya Nyaya Sanhita, 2023.

2. State filed say at Exh.5. I have heard learned Advocate for the applicant and learned APP for the State. Advocate for the accused submitted that the accused is in jail from 03/06/2026 and for sufficient time he was interrogated in the custody. The prohibited articles have been seized. The learned APP submitted that if the accused is released on bail, there is strong possibility of committing similar offence by him. Therefore, bail cannot be granted to him.

3. I have gone through the FIR and case papers. Allegedly, the accused committed an offence under sections 123, 223, 274, 275, 3(5) of the Bhartiya Nyaya Sanhita, 2023. The police papers shows that prohibited contraband Gutka was already seized. Custodial interrogation of the accused has been done. It will take time to complete the investigation. By that time, physical custody of the accused will serve no purpose with certain stringent conditions, the application deserves to be allowed. Hence, the order.

ORDER

- 1) Application is allowed.

2) Applicant/accused Sunil Ramkishan Abuj, be released on bail in the sum of Rs.25,000/- (Rs. Twenty Five Thousand) only, with a surety in the like amount, on the following condition -

(a) He shall not tamper with the prosecution evidence in any manner.

3) Bail be furnished before remand Court.
