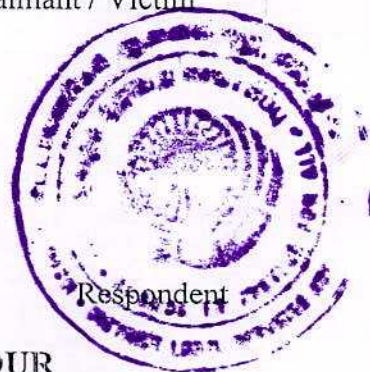

Dispute in Brief:-

The Claimant/Victim filed the application claiming compensation for the injuries sustained in the motor accident which occurred on 16/11/2024 for a sum of 8,85,000/- Eight lakh eighty five thousand only (Rupees only) as compensation.

We, that is the Claimant/Victim and respondents in the above said case have arrived at the compromise to settle the matter as follows:

Terms of Settlement is

- 1) Both the Claimant/Victim, and the respondents/respondents with their Advocate present.
- 2) The matter is discussed and settled.
- 3) The respondent No. agreed to pay a sum of Rs. 8,85,000/-
- 4) (Rupees Only)
- 5) The Claimant/Victim is entitled to the award amount of Rs. 8,85,000/-
- 6) (Rupees Only)
- 7) The respondent No. have to deposit the entire settled award amount of the respective share of the claimant/victim within 4 weeks from the date of this award to the credit of the Bank Account of the claims Tribunal directly by NEFT or FTGS. Victim.
- 8) In default, the respondent No. have to pay interest at the rate of 7.5% per annum from the date of award.
- 9) On Such deposit, the claims tribunal-may disburse the respective share of the claimant/victims to the details furnished by the claimant/victim as follows.
