J U D G M E N T

(Delivered on 06.06.2023)

The accused Nos. 1 & 2 voluntarily pleaded guilty for the offence of which particulars are now read over and explained to them in vernacular. Accordingly, they filed pursis Ex.60. I accept the plea of guilty of the accused Nos. 1 & 2 and hold them guilty for the said offence. Heard the accused Nos. 1 & 2 on the point of sentence. They prayed for leniency. Lenient view is taken as accused Nos. 1 & 2 submitted that, they are only earning member of their family. In the result, I pass the following order:

O R D E R

01. The accused **Nos. 1 & 2** are convicted for the offence punishable under section 12(a) of the Prevention of Maharashtra Gambling Act vide section 252 of Criminal Procedure Code. They are sentenced to suffer simple imprisonment till rising of the Court and to pay a fine of **Rs. 300/- (Rs. Three Hundred Only) each.** In default to suffer simple imprisonment for three days.

02. Accused persons shall surrender their bail bonds.

03. Copy of this order be given to the accused on free of costs.
