Heard.

2. The Ld. Advocate for the applicant urged that the applicant has no concern with the misdeed committed by the Directors of TWJ Associates. There is no allegation or role attributed to the applicant as to propagating the scheme and luring the investors. He urged that similarly situated co-accuse Sachin Shankar Patil is protected by this Court in Anticipatory Bail Application No.7557/2025 dated 07/11/2025. Thus, he requested for similar parity.

3. The Ld. A.P.P seek time to file say.

4. Considering the submissions advanced and contentions raised by the Ld. Advocate for the applicant, it is desirable grant ad-interim pre-arrest bail to the applicant. In the situation, the following order :

ORDER

1. The application (Exh.4) is allowed.
2. Applicant **Munaf Mahmed Mukadam** shall appear before the concerned investigating officer of Warje Malwadi Police Station, Pune on 16/02/2026 for interrogation and in the event of his

arrest, the applicant shall be released on ad-interim pre-arrest bail on execution of PB & SB of Rs.50,000/- with one or two surety of like amount in connection with C.R. No.401/2025 registered with Warje Malwadi Police Station, Pune for the offence punishable u/s.316(2), 316(5), 318(4), 61(2) of the Bharatiya Nyaya Sanhita, 2023 and Sections 21 and 23 of the Banning of Unregulated Deposit Schemes Act, 2019.

3. Thereafter, the applicant shall attend concern police station on Every Monday and Friday between 11:00 a.m. to 02:00 p.m. till further order.
4. Applicant shall submit his permanent and temporary address and mobile numbers to investigator.
5. Applicant shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the Court or to any Police Officer.
