ORDER BELOW EXH.01.

This application is filed under Sec. 24 of the C.P.C. for transfer of R.C.S.No.90/1997 and Spl.C.S. No.647/2026 in any one Court at Shirur, Dist. Pune.

2] It is submitted that the R.C.S.No.90/1997 is filed by opponent No.1 in the Civil Court at Shirur and Spl.C.S.No.647/2026 is filed by applicants. The suit properties and parties are same in both the suits. Both suits are pending in two different Courts at Shirur, Pune. Therefore, it is convenient to continue these suits before one Court, to avoid any complexity in order.

3] The Ld. Advocate for opponent No.1 filed reply at Exh.10. The opponent has no objection to transfer the both the suits in one court.

4] Heard learned Advocate Trupti Kulkarni for the applicants and learned Advocate Shri. Bangar for the opponents. Applicant filed pursis (Exh.7) and submitted that opponent Nos.2 to 19 are the formal parties in the present application.

5] The suit properties and the parties are same. As the opponent has given no objection and to avoid any conflicting orders and inconvenience of the parties, it is just and appropriate in the interest of justice, to transfer R.C.S. No.90/1997 to the Court of C.J.S.D., Shirur, Dist. Pune (Shri. H. R. Patil) wherein the Spl.C.S.No.647/2026 is pending. Hence, the order -

ORDER

1. The application is allowed.
2. The Regular Civil Suit No.90/1997 pending on the file of 2nd Jt. C.J.J.D. & J.M.F.C., Ghodnadi, Dist. Pune (Shri. D. B. Domale) is hereby withdrawn and transferred to the court of Civil Judge Senior Division, Ghodnadi, Dist. Pune (Shri. H. R. Patil) wherein the Special Civil Suit No.647/2026 is pending, for its disposal in accordance with law.
3. The matters to be decided on their own merits.
4. The registry/ Office shall take necessary steps.
5. Application stands disposed of.
