ORDER BELOW EXH.01.

This application is filed under Sec. 24 of the C.P.C. for transfer of two civil appeals in one Court.

2] It is submitted that applicant and respondent have filed RCA No.82/2015 and R.C.A.No.19/2015 respectively against the judgment and decree passed in Spl.C.S.No.280/1999. The R.C.A.No.82/2015 is pending in the Court of District Judge-12, Pune (Shri. D. R. Shetty) and R.C.A.No.19/2015 is pending in the Court of District Judge-26, Pune (Shri. S. R. Agrawal). There is possibility of conflicting judgments. No prejudice would be cause to either of the parties. Hence, prayed to allow the application.

3] The Ld. Advocate for opponents filed reply at Exh.12 and given no objection to transfer both the cases in one Court.

4] Heard learned Advocate Shri. K. U. Dhogande for the applicant and learned Advocate Shri. R. V. Karkande for the opponents.

5] It seems that both the appeal have pending in two different Courts but the subject matter and issues of both the appeals arises from the same suit. Hence, to avoid any conflicting orders and inconvenience of the parties, it is just and appropriate in the interest of justice, to transfer R.C.A.No.82/2015 to the Court of District Judge -19, Pune wherein the earlier appeal R.C.A.No.19/2015 is pending. Hence, the order -

ORDER

1. The application is allowed.
2. The R.C.A.No.82/2015 pending on the file of District Judge-15 and Addl. Sessions Judge, Pune (Shri. D. R. Shetty) is hereby withdrawn and transferred to the court of District Judge-19 and Addl. Sessions Judge, Pune (Smt. A. V. Choudhari) wherein the R.C.A.No.19/2015 is pending, for its disposal in accordance with law.
3. Both the appeals to be decided on their own merits.
4. The registry/ Office shall take necessary steps.
5. Application stands disposed of.
