ORDER BELOW EXH. 6

1. This is an application under Section 503 of the Bharatiya Nagarik Suraksha Sanhita, 2023 for releasing Honda CB Shine motorcycle, bearing registration No. MH-12/RZ-3824, seized during investigation in Crime No. 504/2024, registered with Police Station, Yerwada, Pune.
2. The respondent/State has filed say and strongly opposed the application.
3. Heard. It seems that, the said motorcycle has been seized by the police during investigation of the present crime. The applicant has filed on record verified copies of registration certificate of the motorcycle and his adhar card. It seems from the documents tendered by the applicant, that the applicant is the registered owner of Honda CB Shine, bearing registration No. MH-12/RZ-3824. The applicant has also filed his affidavit along with the application.
4. It is stated by the applicant that, if the seized motorcycle kept in the police station in idle condition for unknown period, there is every possibility of damage to the it due to weather conditions. The applicant has specifically stated that, he is ready to give indemnity bond against the said motorcycle and he will not transfer the it by any mode.
5. It discloses that, the applicant is in need of the said motorcycle for his daily affairs and he is the owner of motorcycle. If

motorcycle is not released, then there is every possibility of damage to the motorcycle if it is kept in idle condition in the police station. In such circumstances, considering the ownership of the motorcycle of applicant, it is just in the interest of justice to release the said motorcycle in favour of the applicant on compliance of certain conditions. Thus, the application is to be allowed subject to compliance of conditions. With this, I proceed to pass the following order.

ORDER

1. The application (Exh.6) is allowed.
2. Honda CB Shine motorcycle, bearing registration No. **MH-12/RZ-3824**, Chassis No. ME4JC652HKG015892, and Engine No. JC65EG0114193 be released in favour of the applicant/accused **Sagar Gorakh Pandit**, on execution of *Supurtnama* Bond of **Rs.1,00,000/- (Rs. One Lac only)** on following conditions ;
 - [i] The applicant shall not dispose of above motorcycle in any manner till disposal of this case.
 - [ii] The applicant shall produce seized motorcycle as and when required as per directions of the Court.
 - [iii] The applicant shall not use the above motorcycle in any offence or in any illegal activity.
 - [iv] Yadi be issued to concerned police station accordingly.
3. The application (Exh.6) is accordingly disposed of.
