ORDER BELOW EXH. 4

1. This is an application filed by applicant Vishal Dattatray Sarode under Section 497 of the Bharatiya Nagarik Suraksha Sanhita, 2023 for releasing Splendor+BLK Stripe 13S (DRS), Motorcycle bearing registration No. MH-14/LK-3471, seized during investigation in Crime No. 441/2024, registered with Police Station, Sangavi, Pimpri-Chinchwad.
2. The respondent/State has filed say and it has no objection to release said motorcycle on certain conditions.
3. Heard. It seems that, the said Motorcycle has been seized by the police during investigation of the present crime. The applicant has filed on record verified copy of aadhar card, registration certificate. It seems from the documents tendered by the applicant that, the applicant is the registered owner of Splendor+BLK Stripe 13S (DRS) motorcycle bearing registration No. MH-14/LK-3471. The applicant has also filed his affidavit along with the application.
4. It is stated by the applicant that, if the seized motorcycle kept in the police station in idle condition for unknown period, there is every possibility of damaging to the motorcycle due to weather conditions. The applicant has specifically stated that, he is ready to give indemnity bond against the said motorcycle and he will not transfer it by any mode. It discloses that, the applicant is in need of the said motorcycle for daily affairs of family and he is the owner of the said motorcycle. If the motorcycle is not released,

then there is every possibility of damaging to the motorcycle, if it kept in idle condition in the police station. In such circumstances, considering the ownership of the motorcycle of the applicant, it is just in the interest of justice to release it in favour of the applicant on compliance of certain conditions. Thus, the application is to be allowed subject to compliance of conditions. With this, I proceed to pass the following order.

ORDER

1. The application (Exh.4) is allowed.
2. Splendor+BLK Stripe 13S (DRS) Motorcycle bearing registration No. **MH-14/LK-3471**, Chassis No. MBLHAW223PGL11988 and Engine No. HA11E7PGL12127 be released in favour of the applicant **Vishal Dattatraya Sarode**, on execution of *Supurtnama* Bond of **Rs.1,00,000/- (Rs. One Lac only)** on following conditions ;
 - [i] The applicant shall not dispose of above Motorcycle in any manner till disposal of this case.
 - [ii] The applicant shall produce seized Motorcycle as and when required as per directions of the Court.
 - [iii] The applicant shall not use the above Motorcycle in any offence or in any illegal activity.
 - [iv] Yadi be issued to concerned police station accordingly.
3. The application (Exh.4) is disposed of accordingly.
