ORDER BELOW APPLICATION U/S. 503 B.N.S.S
PASSED ON 09.06.2026

1. Applicant namely **Mrs Sunita Arun Dhumal** filed present application under Section 503 of B.N.S.S for release of property on supurtnama. The description of property is as follows :

S.No.	Muddemal
1	Rs. 2,48,000/- One gold bead necklace with black beads in the middle (Mangalsutra), of gold weighing 31 grams .
2	Rs. 28,000/- One gold designer ring weighing three and a half grams .
3	Rs. 10,000/- Cash amount, consisting of notes of Rs. 500/-, Rs. 200/-, and Rs. 100/- note numbers not known .

2. According to applicant, he is the owner of above described Gold ornaments and cash. The said ornaments are seized by Phursungi Police Station in Crime No. 63/2026. Applicant is ready to execute a bond and comply the conditions to the satisfaction of the court. Ld. A.P.P submitted that, the said seized ornaments gold articles are important evidence in this offence.

3. The present application be allowed with terms and conditions. I.O. has also filed his say he has no objection to hand over the gold ornaments to the applicant.

4. The applicant has filed on record the verified copy of FIR

and his Aadhar card and receipts of said gold ornaments. Apart from applicant no one has put the claim over the said gold ornaments. No purpose would be served by keeping the gold ornaments in police station. Applicant prima facie has a rightful claim over the same. Hence, I pass following order :

O R D E R

1. The present application is hereby allowed.
2. The interim possession of Gold ornaments and cash shall be handed- over to the applicant **Mrs Sunita Arun Dhumal** till conclusion of the trial, on applicant executing indemnity bond (Supurtnama) of Rs. 2,86,000/-.
3. The applicant shall undertake that, he shall not sell, alienate, transfer or dispose of said Gold ornaments in any manner till conclusion of trial.
4. Applicant shall produce said Gold ornaments and cash as and when directed by the Court or by Police Officer, as the case may be.
5. Police Station, Phursungi shall prepare detail panchanama and take necessary photographs of said Gold ornaments before handing over its possession to applicant on Supurtnama and obtain the endorsement of applicant thereon.
6. Police Station, Phursungi shall get the said Gold ornaments weighed from an authorized Goldsmith in presence of the applicant and obtain certificate of the Goldsmith in that regard.

7. Said panchnama, photographs, indemnity bond (Supurtnama) and certificate of Goldsmith shall be attached with the original case papers of this case.
