**Judgment of Plead Guilty U/Sec. 246(3) of Code of Criminal
Procedure**

In R.C.C. No.106/2021 accused No.1 Ajit Ganesh Pawar, accused No.2 Pappu Musafir Gupta and accused No.3 Prabhu Pirappa Narbale have been charged for the offence punishable U/Sec. 3(a) Railway Property (Unlawful Possession) Act 1966 (RPUP in short). Accused No.1 and 2 are currently on bail. Accused No.3 who is in M.C.R. produced before me by R.P.F. Pune from jail.

2. R.C.C. No. 106/2021 is at present on the stage of charge. Today accused No.3 has filed pursis before me at Exh.10 and submitted that, he is ready to plead guilty. He further submitted that, he has been lodged in jail for many days. Therefore he prayed that, leniency be shown and minimum sentence be imposed upon him.

3. I perused the case record. Accused No.1 and 2 were released on bail on 25/02/2021. At present accused No.3 is in M.C.R. and is today produced before me from jail. The case is at the stage of framing charge. The accused was explained about the contents of offence for which the case has been registered against him. He was also explained about the quantum of punishment. However, he pleaded guilty to the offence. I verified him and found that, the accused has voluntarily pleaded guilty to the offence. The pursis at Exh.10 clearly reveals that, the accused has voluntarily pleaded guilty to the offence.

4. Therefore, considering the fact that, the accused person has undergone detention in jail from 26/03/2021 till 21/02/2022 and has voluntarily pleaded guilty to the offence, I am of the opinion that, the following sentence would meet the ends of justice.

ORDER

1. Accused No.3 Prabhu Pirappa Narbale is convicted for the offence punishable U/Sec. 3(a) Railway Property (Unlawful Possession) Act 1966 vide section 246(3) of Code of Criminal Procedure.
2. Accused No.3 Prabhu Pirappa Narbale is sentenced to rigorous imprisonment of 10 months 26 days.
3. Accused No.3 Prabhu Pirappa Narbale is in jail from 26/03/2021 till 21/02/2022. The period undergone by the accused person in the jail be set-off vide section 428 of Code of Criminal Procedure.
4. Muddemal in the case be preserved for trial against other accused persons.
5. Copy of this judgment to be given free of cost to the accused.
