ORDER BELOW EXH.1

(Passed on 16th March, 2026)

This is an application filed by applicant Umesh Vijay Kumbhar under Section 503 of the Bhartiya Nagarik Suraksha Sanhita, 2023 for releasing his Honda Company Activa Motorcycle bearing registration No. MH14 KX7963, Chassis No.ME4JK155CPG030418, Engine No. JK15EG4019478 (herein after referred as “vehicle”). According to the applicant, he is owner of the seized vehicle.

2. It is the contention of applicant that an offence was registered at State Excise Department, F Region, Pune vide Crime No.306/2025 for an offence punishable under Section 65(a)(b)(c)(e)(f) of the Maharashtra Prohibition Act. In the said offence Honda Company Activa Motorcycle bearing registration No. MH14 KX7963, Chassis No.ME4JK155CPG030418, Engine No. JK15EG4019478 was seized. It is submitted that, the applicant is not concerned with the said offence and he is the only owner of the said vehicle.

3. The applicant has filed documents regarding said vehicle i.e. R.C. Book and insurance policy. On careful scrutiny of these documents it prima facie appears that applicant is the real owner of the vehicle. The documents filed on record established ownership of applicant over the vehicle. No other person except applicant has applied for vehicle. Record shows that State Excise Department, F Region, Pune has registered an offence vide Crime No. 306 of 2025 for an offence punishable under

Section 65(a)(b)(c)(e)(f) of the Maharashtra Prohibition Act against unknown person. I do not find any reason to reject this application. On the other hand, if application is rejected the condition of vehicle will be deteriorated due to its idle standing in the premises of State Excise Department, F Region, Pune. Applicant is ready to abide all the conditions imposed by the Court while releasing the vehicle. Hence, I proceed to pass the following order.

:: ORDER ::

- 1) Application is allowed.
- 2) State Excise Department, F Region, Pune is directed to release the seized Honda Company Activa Motorcycle bearing registration No. MH14 KX7963, Chassis No.ME4JK155CPG030418, Engine No. JK15EG4019478 to applicant Umesh Vijay Kumbhar on Supurtnama bond of Rs. 1,00,000/- (One Lakh only) on following conditions-
 - a) The applicant shall not change the look and nature of said vehicle and shall not alienate the same till the disposal of matter.
 - b) Investigating officer is directed to make panchanama of handing vehicle to the applicant.
 - c) The photographs of vehicle be obtained from various angles at the expenses of applicant.
 - d) The applicant shall produce the vehicle before the court whenever required and directed during trial.
 - e) Copy of order, supurtnama bond shall be placed in the case papers of Crime No.306/2025 of State Excise Department, F Region, Pune.
