The officer in-charge after the completion of the investigation in Crime No.202/2026 registered with Dighi Police Station has filed charge-sheet under section 193 (3) of the B.N.S.S against the accused Abhimanyu Babasaheb Tarade for an offence punishable under sections 69, 115(2), 351(2)(3) of the Bhartiya Nyaya Sanhita, 2023. Read the Charge-Sheet, the statement and documents filed along with it.

2. Heard learned A.P.P. After perusing the accusation made in the charge-sheet it appears to me that the offence punishable under section 69 of the B.N.S. alleged to have been committed in the charge-sheet, which is exclusively triable by Hon'ble Court of Sessions.

3. Today accused and his learned counsel are present before the Court. The compliance under section 230 of B.N.S.S was complied. Therefore, the cases is necessary to be committed to the Hon'ble Court of Sessions for trial.

ORDER

- 1 The case is hereby committed to Hon'ble District and Sessions Court, Pimpri Chinchwad for it's trial according to law as per provision under section 232 of the B.N.S.S.
- 2 The accused is released on bail by order of Hon'ble Sessions Court, Pimpri Chinchwad.

- 3 The provisions of section 230 of B.N.S.S is complied with the copies of the Police Report, documents and statement of witnesses are supplied to the accused.
- 4 The accused is directed to remain present before the Hon'ble District and Sessions Court, Pimpri Chinchwad on **09/10/2026** at 11.00 A.M.
- 5 The record of the case and the documents and articles if any, which are to be produced in the evidence be sent to the Hon'ble District and Sessions Court, Pimpri Chinchwad through Court messenger.
- 6 The public prosecutor be notified of the commitment of the case to the Court of Sessions, Pimpri Chinchwad.
