- 1) That present application is false and bundle of

**IN THE HON'BLE COURT JMFC, PIMPRI, AT PUNE**

PWDVA Execution No. 8/2024

Bindu Rajesh Thakkar ... Applicant

Versus

Rajesh Ramji Thakkar ... Respondent

Humble Application on behalf of Applicant is as under:

1. That Hon'ble Court on last date pleased to pass an order to issue NBW against the Respondent as he failed to clear the long due arrears of maintenance.
2. The Respondent later tried to convince the Applicant and filed application on the same day to cancel the NBW with the proposal of giving three cheques of Rs. 2,00,000/- (dated 15.02.2025), Rs. 3,00,000/- (dated 18.02.2025) and Rs. 9,00,000/- (dated 28.02.2025) to clear partial arrears of total Rs. 14,00,000/- before next date i.e. 01.03.2025. Respondents also undertake before Hon'ble Court that these cheques will not be dishonored in any case.
3. Hon'ble Court accordingly accepted the undertaking of Respondent and pleased to cancel the NBW against the Respondent. But as usual it proved to be another illegal act of Respondent where he played fraud not only with Applicant but also with Hon'ble Court to get cancelled the NBW anyhow resorting to falsehood.
4. The Applicant states that first cheque of Rs. 3,00,000/- (dated 18.02.2025) got dishonored which the Respondent after getting idea that Applicant again can approach the Hon'ble Court, got agreed to deposit the amount in his bank account and asked Applicant to

redeposit the said cheque of Rs. 3,00,000/- (dated 18.02.2025) which later got cleared on 24.02.2025.

5. That again the Applicant got the idea of cheating and fraud by the Respondent when she deposited the cheque of Rs. 9,00,000/- (dated 28.02.2025) on 28.02.2025 and later she got to know that Respondent intentionally has not maintained the required balance in his bank account which clears that this cheque of Rs. 9,00,000/- (dated 28.02.2025) is going to be dishonored.
6. It all establishes that Respondent has played fraud with the Applicant and Hon'ble Court to get the favorable order anyhow and this intentional act of Respondent is not only an act of breach of order of Hon'ble Court but also contempt of Hon'ble Court and Respondent needs to be punished severely for his illegal act.
7. It is therefore most humbly prayed that:
  - a) Order kindly be passed to arrest the Respondent issuing NBW against him for not clearing the arrears of maintenance and to pay off the entire arrears till date due and payable.
  - b) Contempt proceedings kindly be initiated against the Respondent.
