Examination-in-chief by Ld. APP Shri. Bargaje -

1. My educational qualification is B.H.M.S. and M.B.A. in Hospital Management. Today, I am coming before this Court as per authority letter given by Dr.Madhav Sheshrao Chavan. I have perused that authority letter dtd.10.09.2025, its contents are true and correct, it bears signature of Dr. Shri Chavan. It marked at **Exh.39**. Today, I am coming with IPD register for the year 2016-17, 2017-2018. As per IPD register 2016-17 one Devansh Kangralkar was admitted in our hospital on 09.08.2017 at about 12.30 pm. He was admitted in our hospital till 11.08.2017 at 6.00 pm. He was admitted in the hospital for the reason of "acute bacteremia". He was admitted in our hospital for 3 days. I have submitted Xerox copy of IPD register 2016-17, I have compared this Xerox copy of IPD register with original IPD register. It is one and the same with original. Xerox copy of IPD register for the year 2016-17 is marked at **Exh.40**. As per medical rules all IPD files were destroyed therefore, I have submitted xerox copy of paper notice. Now, that paper notice is shown to me, it is true and correct hence it is mark at **Article A**. I could not file medical bills of Devansh Kangralkar for the year 2016-17 because Manorama Software which was working in the year 2017 was not in operation. Therefore, it's data could not be available with us.

02. Now, exh.28 shown to me, it appears that, date of admission of Devansh Kangralkar was wrongly mentioned in that Exh.28. Amount and duration which was mentioned on Exh.28 is one and the same as per my original record which is at Exh.40.

03. Today, I am coming with IPD register for the year 2018-19. As per IPD register 2018-2019 one Devansh Kangralkar was admitted in our hospital on 07.06.2018 at about 11.00 pm. He was admitted in our hospital till 13.06.2018 till 6.00 pm. He was admitted in the hospital for the reason

of "viral fever with biocypenia". He was admitted in our hospital for 7 days. I have submitted Xerox copy of IPD register 2018-19, I have compared this xerox copy of IPD register with original IPD register. It is one and the same with original. Xerox copy of IPD register for the year 2018-19 is marked at **Exh.41**.

04. Today, I am coming before this Court only for comparing record at Exh.28 it's with original record. I am working with Dr.Chavan since 6 years in this hospital.

Cross-Examination (By Shri. Prasad Kangralkar in person)

05. It is true to say that, on August 2017 two more patients were admitted in our hospital for "acute bacteremia". It is true to say that, I have not medical record of Devansh hence I could not say that what is cause of his "acute bacteremia". It is true to say that, on 11.08.2017 no psychological test of Devansh was conducted by our hospital. It is true to say that, on 11.08.2017 Devansh was admitted in our hospital for the purpose of test of fever and his illness. It is true to say that, on 07.06.2018, no psychological test of Devansh was conducted. It is true to say that, original bill, investigation report, medical bill, diagnosis report were sent to Insurance Company by our hospital. It is not true to say that, our hospital can call that documents from Insurance Company. It is true to say that, Devansh was admitted in our hospital for that alleged period for viral fever and not for mental trauma.

Re-examination by Ld. APP Shri. Bargaje -

06. If any child is under psychological trauma, there may be possibility of affecting his immunity system. As per this medical report Devansh was admitted in our hospital for viral fever and low immunity is also one of the reason for his viral fever.

Cross-Examination (By Shri. Prasad Kangralkar in person)

07. It is true to say that, I can not say that Devansh was affected by viral fever on the reason of his mental trauma. I could not recollect that on 09.08.2017, when Devansh was admitted in our hospital, at that time some one was intimated to our hospital in respect of domestic incident.
