Today accused are produced before the court from Jail through video conferencing by the jail authority. As per charge-sheet and the police papers filed alongwith it appears that, accused are charged with the offence punishable under section 310(2), 115(2), 352, 351(2), 324(4) of Bhartiya Nyaya Sanhita, section 4(25) of Arms Act and and section 135 of

Maharashtra Police Act. The offence alleged U/s. 310(2) of Bhartiya Nyaya Sanhita is triable by the Hon'ble Sessions court. The case needs to be committed to the Hon'ble Sessions Court for trial. The copies of police report & other documents as specified in section 230 of Bharitya Nagarik Suraksha Sanhita, 2023 have been supplied to accused by sending the copies of final report to jail authorities. Accused are in jail. Accused have orally submitted that his advocate will conduct their matter before the Hon'ble Sessions Court. Intimation about the committal of the case is given to the accused. Therefore, I pass the following order.

ORDER

1. The case be committed to the Hon'ble Sessions Court, Pune.
2. Accused are remanded to magisterial custody until committal of the case & also during and until the conclusion of trial before the Court of Sessions vide section 232 of Bharitya Nagarik Suraksha Sanhita, 2023.
3. The Jail Authorities is directed to produce accused before the Hon'ble Court of Sessions on receiving production warrant from that Court and accused are directed to remain present before Hon'ble Court of Sessions on **04.02.2025**.
4. The record of the case, the documents and the articles if any which are to be produced in evidence, shall be sent to the Hon'ble Sessions court, Pune on or before **04.02.2025**.

5. The Police Station Officer, Police Station MIDC Bhosari is directed to produce muddemal property, if any, in the Court of Sessions on or before **04.02.2025** positively.
6. The Public Prosecutor shall be notified of the commitment of the case to the Hon'ble Sessions Court, Pune.
