



Committal order below Exh. 1 in R.C.C.
No.142/2025

Sachin Madhukar Ghone Vs. Anjali Vasant Ahire
(Passed on 07-03-2026)

Complainant Sachin Madhukar Ghone has filed present private complaint on 25/07/2022 against accused No. 1 Anjali Vasant Ahire, Accused No. 2 Ashwini Ankush Funde, Accused No. 3 Lata Namdev Waghole, Accused No. 4 Surekha Bhikaram Rajiwade and Accused No. 5 Ashwini Sonawane alleging commission of offences punishable under Sections 166, 211, 219, 120(A) r/w 34 of the Indian Penal Code and Section 3(p)(q) of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act. The said application under Section 156(3) of Cr.P.C. came to be rejected by this Court on 30/06/2025 and thereafter the complaint was directed to proceed as private complaint and was registered as Regular Criminal Case No. 142/2025.

2] During the course of proceedings, my Ld. Predecessor has called a report from police under Section 202 of the Criminal Procedure Code. Accordingly, report was called from Bhor Police Station on 21/10/2023. The said report was received on 30/09/2024. Accordingly process came to be issued against accused Nos. 1 to 5 for the offences punishable under Sections 166, 211, 219, 120(A) r/w 34 of the Indian Penal Code and Section 3(p)(q) of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act. In pursuance of the said order, accused Nos. 1 to 5 appeared before this Court and filed their say.

3] Accused Nos. 1 to 5 are present before the Court. Heard both parties.

4] Accused Nos. 1 to 5 have been charged under Sections 166, 211, 219, 120(A) r/w 34 of the Indian Penal Code and Section 3(p)(q) of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act. Out of the said offences, the offence punishable under Section 3(p)(q) of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act is exclusively triable by the Court of Sessions / Special Court. Therefore, this Court has no jurisdiction or power to try the present case. Hence, the case is required to be committed to the Court of Sessions, Pune. The copies of police report and other documents as specified in Section 207 of Criminal Procedure Code, 1973 have been supplied to the accused. Hence, I pass following order -

ORDER

1. The case be committed to the Court of Sessions, Pune.
2. Accused Nos. 1 to 5 are directed to remain present before the court of Sessions on 01/04/2026.
3. The record of the case, documents and articles which are to be produced in evidence shall be sent to the Court of Session, Pune.
4. The Police Station Officer of Concerned Police Station is directed to produce muddemal property if any in the Court of Session on or before 01/04/2026 positively.
