**State of Maharashtra

ORDER BELOW EXH.2

This application for releasing accused-Nilesh Ramdas Shinde on interim bail is filed as 'B' Summary is filed against him by the Investigating Officer in the form of report to be submitted to the Court. It is contended that accused was alleged to have committed offence punishable under sections 137(2), 64(1), 351(1), 3(5) of the Bharatiya Nyaya Sanhita (BNS) and under section 4, 6, 8, 12 of the Protection of Children from Sexual Offences. No protest petition is yet filed.

2. Ld. APP for State submitted that though 'B' Summary is filed, the complainant shall be heard in the matter, and therefore, the application may be rejected.

3. Heard Ld. advocate for accused and Ld. A.P.P. for State. Perused the record of 'B' Summary.

4. 'B' Summary is filed by the Investigating Officer showing that there is no evidence against the accused, in spite of making detailed investigation and the prosecution was instituted only with oblique motive. Be that as it may, the notice will be issued to the complainant, victim, parent/relatives of victim in the manner provided by law to follow the appropriate procedure in the facts and circumstances. Keeping in view the fact that a case of no evidence is brought against accused without any indictment, he may be released on interim bail subject to conditions till further orders of Courts. Hence, the following order:

ORDER

1. Interim application (Exh.2) is hereby allowed.
2. Applicant-accused Nilesh Ramdas Shinde be released on interim bail in Crime No. 641/2024, of Baramati City Police Station, on his executing Personal Bond in the sum of Rs. 50,000/- and a Surety in the like sum, and he shall surrender as and when directed by this Court, before jail authority.
3. The applicant/accused shall not threaten, pressurize or dissuade complainant, victim and prosecution witnesses directly or indirectly, and shall not tamper evidence.
4. The applicant/accused shall produce identity proof alongwith his contact numbers, and numbers of those persons who shall be approached in case the accused is found unavailable.
5. The applicant/accused shall not commit any offence during period of release.
