**Examination in chief by A. P. P. Shri. Lohkare :**

1] On 01/02/2015 I was working as Medical Officer at Sub District Hospital, Indapur. On that day at about 04.50 p.m. Ashwini Bhale, Haribhau Bhale, Dadaso Bhale came to the hospital along with police yadi. There was history of assault by stone and wooden stick at about 02.00 p.m..

2] I have examined Ashwini Dadaso Bhale. I examined 04.50 pm. After examination I found following injuries-

1. C.L.W. on parietal region, center. Size of injury 5 cm x 3 cm into bone deep. Clotted blood was present. It was simple in nature. Caused by hard and blunt object and injury was within 6 hours.

3] Thereafter, I have examined Dadaso Shankar Bhale. After examination I found following injuries -

1. Contusion on back inter scapula region. Size of injury 8 cm x 4 cm. Reddish in colour. It was simple in nature. Caused by hard and blunt object and injury was within 6 hours.

4] Thereafter, I have examined Haribhau Sukhdeo Bhale.

After examination I found following injuries -

1. Contusion on fronto-parietal region. Size of injury 6 cm x 4 cm. Reddish in colour. It was simple in nature. Caused by hard and blunt object and injury was within 6 hours.

5] After examination I have issued the injury certificate. Now the injury certificate of Ashwini Bhale is shown to me. It bears my signature. The contents are true and correct. Hence, it is marked as **Exh.73**. Now injury certificate of Dadaso bhale is shown to me. It bears my signature. The contents are true and correct. Hence, it is marked as **Exh.74**. Now injury certificate of Haribhau bhale is shown to me. It bears my signature. The contents are true and correct. Hence, it is marked as **Exh.75**. The above injuries can be possible if anybody hit any person by hard and blunt object like stone or wooden stick.

**Cross Examination on behalf of accused by Advocate Shri. S. H. Khade :**

6] I have worked as a Medical officer for 33 years. Today I have not brought original M.L.C. register. Daily I used to examined 100 to 200 patients. I did not know the patient personally. On the basis of M.L.C. register we issue injury certificate. It is not true to say that without going into M.L.C. register I cannot state whether injury certificate is correct or not ?. In the injury certificate thumb impression of patient is not taken. It is not true to say that I have not issued medical certificate as per medical jurisprudence. If any

person fall on the rough surface then the injury mentioned in the injury certificate can occur. It is not true to say that the concerned injured are my old patients. In the injury certificate of Haribhau the time of examination is not mentioned. It is not true to say that without examining patient I have issued false certificates. It is not true to say that I have not examining the patient. It is not true to say that I am deposing false.
