1. The application below Exh.10 is filed for permission to withdraw the application and the domestic incident report filed by the Protection Officer be filed in case bearing Cri.Misc. Application No. 113/2022. On perusal of record, it appears that, on a report of Protection Officer and his application, the present case bearing Cri.Misc. Application No.99/2022 is registered under The Protection Of Women From Domestic Violence Act, 2005(in short 'D.V.Act'). However, it is contended that, the said application is not in detail. Therefore, applicant has filed another application bearing No.113/2022 under D.V. Act, for various prayers. The application bearing Cri.M.A.No. 99/2022 contains a domestic incident report of Protection Officer. Applicant is not willing to proceed with the case bearing Cri.M.A. No.99/2022. Therefore, applicant prayed for allowing an application.

2. Respondent has filed his say, contending that, false application is filed. Application is not maintainable. Application is filed only with an intention to harass respondent. Therefore, he prayed for rejection of an application.

3. Perused application, say. Heard.

4. On perusal of record, it appears that, present application is filed by the Protection Officer. Thereon, the notice was issued to respondent. Alongwith the said application, the Protection Officer has filed the domestic incident report. The case bearing Cri.M.A. No.113/2022 is filed by the applicant under the D.V.Act. for various prayers. It appears that, applicant is not willing to proceed with application bearing Cri.M.A. No.99/2022.

Considering aforesaid mentioned facts and circumstances of case, it is just and proper to allow applicant to withdraw the application bearing Cri.M.A. No.99/2022 and the domestic incident report filed by the Protection Officer be filed in case bearing Cri.M.A. No.113/2022. Hence, I proceed to pass following order-

ORDER

1. Applicant is permitted to withdraw the application bearing Cri.M.A. No.99/2022.
2. The concerned clerk is hereby directed to annex the domestic incident report of the Protection Officer in case bearing Cri.M.A. No.113/2022 and same should be mentioned in in roznamas of Cri.M.A. Nos.99/2022 and 113/2022.
