That, you accused, on above date time and place, drove above said vehicle in a manner so rash or negligent as to endanger human life and caused grievous hurt to Prathmesh Shashikant Bhosale who is brother of the complainant and thereby committed an offence punishable under 338 of the Indian Penal Code and within my cognizance.

That, you accused, on above date time and place, drove aforesaid vehicle in a manner which is dangerous to the public, committed mischief by causing wrongful loss or damage to the vehicle of the complainant value at rupees more than 50/- and thereby committed an offence punishable under Section 427 of Indian Penal Code and within my cognizance.

That, you accused, on the above said date, time and place, drove the above said vehicle in the speed or in a manner which is dangerous to the public having regard to the situation of the road and traffic and time and thereby committed an offence punishable under section 184 of the Motor Vehicle Act, 1988 and within my cognizance.
