





ORDER

The accused Ankush Lahu Kamble is present before the Court and filed pursis at Exh. 03. He voluntarily pleaded guilty before this court in spite of the consequence of the punishment explained to him in vernacular. I accept his plea being voluntarily and hold him guilty. He prayed for leniency as he is only bread earner of his family. Hence, taking the circumstances of the case into consideration and the nature of the offence, I pass the following order.

ORDER

The accused Ankush Lahu Kamble is convicted for the offence punishable u/sec.285 of Bharatiya Nyaya Sanhita, 2023 and is sentenced to pay a fine Rs. **500/-** in words (Rs. Five Hundred only) in default to suffer simple imprisonment for two days.
