**ORDER BELOW EXH.01 IN Cri.M.A. NO.260/2023**

[Padma Kisan Pasalkar Vs. Sunil Vitthal Ghadage & Ors.]

(Passed on 3rd November, 2023)

Heard Ld. Advocate Shri. S. B. Bhoite for the complainant at length. Read the complaint and documents including copies of printed NCR 345/2023 of Daund Police Station, Application dtd. 18.03.2023 of complainant to P.I. of Daund Police Station, typed complaint of complainant dtd. 16.01.2014 to Tahasildar, Daund Tahasil, S.P. of Pune filed along with Exh.03.

02. Complainant alleged that accused nos. 01 to 04 have committed offence p/u/s. 504 and 506 r/w 34 of the I.P.C. on 17.03.2023 at 06.00 p.m. in Gut No. 110/2 Mauje Navin Gar, Tal. Daund, Dist. Pune owned by husband of the complainant. Accused nos. 01 and 02 are real brothers, accused nos. 03 and 04 are their wives, there is north-south bandh between Gut of complainant and accused. But accused used to dig bandh in complainant's land. Accused obstructed cultivation of complainant's land and harassed her prior to this also accused were abused and beaten complainant and her husband on the same count and complainant has complained about it. But there is no effect on the part of accused. On the day of incident accused nos. 01 to 04 were came in agricultural land of complainant. Accused nos. 01 and 02 abused complainant in filthy language. Accused nos. 03 and 04 also abused to complainant in filthy language. When complaint ask not to abuse in filthy language. Accused get hyper and ran towards person of complainant. Her husband came and he taken complainant on other side. On that time also accused her husband in filthy language and threatened to kill them. On 18.03.2023 complainant gave written complaint at Patas Out-Post but no action taken by Yavat PS. But police have filed NCR against accused. Hence, complainant filed present complaint.

03. The offences p/u/s. 504 and 506 of the I.P.C. are non cognizable one. Hence, considering allegations in the complaint and nature of offences mentioned in the complaint, I am of

opinion that it is necessary to verify the complainant. Hence, I pass following order :-
