I do hereby on solemn affirmation state that,

Examination-in-chief for the prosecution by Ld. A.P.P. Smt. Bhosle-

1. I am a MBBS Doctor. On 08/03/2023 I was serving as a Medical Officer at Sub-District Hospital, (S.D.H.) Daund. Since 07/03/2023 at 9.00 am to next day 9.00 am i.e. 08/03/2023 I was on call duty Medical Officer. On 08/03/2023 in the early morning at about 1:50 am I have examined Sunil Ramchanrda Aatole and Aabaso Ramchandra Aatole. Injured/patient was brought by police officers of police station, Daund. At the time of physical examination injured told that, they were physically assaulted by known persons.

2. Thereafter, firstly I have physically examined the patient Sunil Ramchandra Aatole. The patient was having black mole on right side of abdomen near umbelicus, as a identification mark. After examination I found four types of following injuries -

- 1] Contused lacerated wound over left side of cheek having size 3 cm X 0.5 cm X 1 cm.
- 2] Abrasion over anterior side of left thigh, having size 1cm X 0.2 cm.
- 3] Blunt trauma over the left side of forehead.
- 4] Blunt trauma over left shoulder and back.

3. The above injuries were simple in nature. I have advised x-ray and CT Scan of skull of patient. On the basis I have issued injury certificate now injury certificate is shown to me. It bears my signature. Contents are true and correct. Hence it is **Exhibited on 38.**

4. Thereafter I examined patient namely Aabaso Ramchandra Aatole on 08/03/2023 at about 2:10 am. Patient came with the history that, he was assaulted on 07/03/2023 at about 11:30 pm by known person. Upon examination I found following injuries -

- 1] Blunt trauma to back.
- 2] Blunt trauma on both thighs.
- 3] Blunt trauma on occipital region of head.
- 4] Blunt trauma and swelling below left knee joint.
- 5] Blunt trauma and tenderness over left sole(ankle joint).

Above all injuries were simple in nature. I have advised X-ray of left knee joint and left ankle of patient. On that basis I have issued injury certificate, now injury certificate is shown to me. It bears my signature. Contents are true and correct. Hence it is **Exhibited on 39.**

5. Both patients did not came back with their X-ray and CT scan reports respectively.

6. It is true to say that, injuries mentioned in the injury certificates Exh.38 and 39 are possible with the help of wooden stick and hoe/spade (खोरे/फावडे).

Examination-in-chief Over.

Cross examination by Adv. S.S. Shaikh for accused-

7. It is true to say that, the witness summons is received to me. It is

true to say that, today I have not brought the MLC papers of both patients. It is true to say that, on Exh.38 and 39 I have not written name of the persons who have assaulted both injured/patients. It is true to say that, I have not written about assault committed by wooden stick in the history mentioned at Exh.38. It is true to say that, patient/injured namey Sunil has not told anything that, he was assaulted by wooden stick, therefore, I have not written in the history of patient mentioned below Exh.38.

8. It is true to say that, both injured did not mention about human bite over chin and thigh. It is true to say that, I have not mentioned human bite injuries in the injury certificates Exh.38 and 39. It is true to say that, I have not written object/weapon of assault in the sixth column of injury certificates Exh.38 and 39. It is true to say that, it is necessary to mention the age of injuries in the injury certificates. It is true to say that, I have not mentioned age of injuries in the injury certificates Exh.38 and 39. It is true to say that, I have not taken signatures or thumb impressions of patient/injured on the injury certificates Exh.38 and 39. It is true to say that, I can give opinion about internal injuries only after perusal of X-ray and CT scan reports. It is true to say that, at the SDH Daund there is facilities of operation and the patients can be treated as indoor. It is true to say that, at SDH Daund X-ray machine and its facilities are available. It is true to say that, I have not mentioned about the stiches taken on the both injured/patient. Witness volunteers that, information about the stiches is written on case paper of injured, it is not necessary to mention about stiches on injury certificate. It is true to say that, without referring case papers I can not firmly says that, patient was having stiches on that day. It is true to say that, I have not referred injured to any other hospital for further treatment. It is true to say that, I have not written letter number on injury certificates Exh.38 and 39. I can not say that, both injured are present in the court premises. It is not true to say that, I am well aware or acquainted with injured/patient Aabaso Aatole, prior to date of incident. It is not true to

say that, patient Aabaso Aatole used to come at SDH, Daund for his work regularly. It is not true to say that, on the say of patients I have written the injuries and object/weapon of assault on injury certificate Exh.38 and 39. It is not true to say that, the injuries mentioned in the injury certificate Exh.38 and 39 are possible if, patient falls on the hard surface. It is not true to say that, if patient falls from the motor cycle on hard surface on road, then the injuries mentioned in the injury certificate Exh.38 and 39 are possible. It is not true to say that, I am deposing false on the say of patients/injured. It is not true to say that, due the acquaintance with the patients, I am deposing false. It is not true to say that, I am deposing false.
