DEPOSITION OF P.W. NO. 4 FOR THE PROSECUTION.

I do hereby on solemn affirmation state that :-

Examination in Chief for Prosecution by Ld. A.P.P. Shri. S. P. Andhale :-

01. My hospital is from 2021 till today. On 26.02.2023 patient by name Sonali Zagade was brought to my hospital at about 11.00 p.m.. She was unconscious. Shw had a history of assault on the same day. I registered the MLC and informed the Kedgaon police station. Now the letter shown to me was sent by me to Kedgaon police station. As it is xerox, so it is given **Article B**. Patient was unconscious for one to two hours. The certificate now shown to me was given by me in respect of unconscious state of patient. It bears signature of residential doctor Dr. Prasad Kambale which I can identified as he is working with me. As it is photocopy so given **Article C**. I examined the patient and she had not critical injuries. I had issued medical certificate to police. Now the MLC shown to me is the same. It bears my signature and seal of my hospital. Its contents are true and correct. It be exhibited as **Exh. 34**. Today I have brought the original file of indoor patient. The certificate of Exh. 34 was issued on basis of the original documents kept in the file of hospital. Patient was discharged on 01.03.2023 at about 9.45 p.m.

Examination in Chief completed.

Cross-examination for the accused by Ld. Advocate Shri. P. B. Giramkar :-

02. I have completed my BHMS degree in 2010. It is true to say that I knew the patient from before as she was working with claim settlement department of my hospital. The patient had a claim settlement company by name Sharethumb to which my hospital was referring the patient. I also knew the husband of patient and I had information about the divorce case pending between them. It is true to say that in the compromise agreed between the parties, the settlement amount of Rs. One lakh was given to me by her husband in order to hand it over to his wife. It is true to say that as the compromise could not get successful, so I returned that amount to husband of patient. It is true to say that the incident occurred in a place behind the hospital which was given on rent to alleged patient to carry out her claim settlement work. It is true to say that the place given to complainant was not in use by the hospital and therefore it was given to them. The witness voluntarily deposes that the alleged place is separate and not attached to the hospital. It is true to say that the letter of Article B was issued when police came to hospital for enquiry. It is true to say that patient told the history of beating but there was no marks of injury on her body. Patient was unconscious when brought to hospital. It is not true to say that I am deposing false in order to help the patient as she was working with me.
