ORDER BELOW EXH.05

Accused namely Siddhu Rasiklal Chavan, Prashant @ Prasad fhotya @ Bandu Kale and Babusha Gulab Kale have filed this bail application. The Ld. Advocate for accused submitted that, the charge-sheet has filed in this crime. Police have not recovered muddemal from these accused persons. Investigation has completed. The offences levelled against accused are triable before this Court. Accused are local resident. They are ready to furnish sureties and also ready to abide the conditions imposed by the Court. They will not tamper and hamper to the evidence of prosecution. Trial will take time to dispose of the present matter. Hence, they lastly prayed to release them on bail.

2. The learned APP file his say to this application at Exh.06 and submitted that, the allegations levelled against accused are serious in nature and nonailable one. There is a punishment to the section 457 of IPC is upto extended fourteen years. Record shows that, various gold ornaments were recovered from accused. Several offences of similar types committed by these accused at multiple places. It shows that, accused are habitual in nature. Other accused yet to be arrested. If they released on bail accused will abscond and will commit similar types of offences. Hence, he lastly prayed to reject the present application.

3. Perused the application and say. Heard both sides. There are allegations against accused in respect of sec. 457, 380 of IPC. Record shows that, police have filed charge-sheet in this crime. Though other accused persons yet to be arrested trial will take time to dispose of the matter. Almost the investigation has completed. The offences levelled against accused are triable by this Court. Therefore, now it is not necessary to keep the accused persons behind the bar as their personal liberty would be curtail. So, considering these aspects it is required to release the accused on bail by imposing some conditions. Hence, following order:

ORDER

1. Accused namely namely Siddhu Rasiklal Chavan, Prashant @ Prasad fhotya @ Bandu Kale and Babusha Gulab Kale are hereby released on bail of Rs.25,000/- each with P.B. and S.B. of like amount.
2. They shall not temper or hamper to the informant and witnesses.
3. They shall furnish their addresses and contact numbers.
4. They shall not commit any offence and not indulge in any similar offence.
5. They shall not leave India without permission of the Court.
6. They shall comply with chapter I paragraph 1 to 6 of the Criminal Manual 1980 (in view of order of Hon'ble High Court passed in Criminal Application 28 of 2010 in Public Interest Litigation No.25 of 2010 of January 29, 2020).
