COMMITTAL ORDER BELOW EXH. NO.1.

1. Accused No.1 namely ***Nitin @ Deva @ Pravin Suresh @ Suraj Chavan*** and accused No. 2 namely ***Ganesh Tanaji Salunke*** are produced before the Court through video conference by the Jail Authority. Accused No. 1 and 2 are under trial prisoners. They are facing the trial of the offence punishable under Section 103, 3(5) of the Bharatiya Nyaya Sanhita, 2023.

2. Accused No. 1 and 2 are represented by their Advocates. It appears that accused have already supplied copy of the charge-sheet through concerned Jail Authority vide letter No.621 of 2026 dated 14/05/2026 in view of compliance of Section 230 of the Bharatiya Nagarik Suraksha Sanhita, 2023. The alleged offence under Section 103, 3(5) of the Bharatiya Nyaya Sanhita, 2023 is triable by the Hon'ble Session Court, Ghodnadi, Tal. Shirur, Dist. Pune. Hence, present case is required to be committed to the Hon'ble Session Court, Pune. Hence, I proceed to pass the following order.

:: ORDER ::

1. Case is committed to the Hon'ble Sessions Court, Ghodnadi, Tal. Shirur, Dist. Pune.
2. The concerned Jail Authority is directed to produce the accused namely accused No.1 namely ***Nitin @ Deva @ Pravin Suresh @ Suraj Chavan*** and accused No. 2 namely ***Ganesh Tanaji Salunke*** abefore the Hon'ble Court of Session, Ghodnadi, Tal. Shirur, Dist. Pune on 19/06/2026.

3. The record of the case and documents and articles, if any which are to be produced in evidence shall be sent to the Hon'ble Court of Session, Ghodnadi, Tal. Shirur, Dist. Pune.
4. The Police Station Officer, Shirur Police Station, Tal. Shirur, Dist. Pune be directed to produce muddemal property, if any, in the Hon'ble Court of Session, Ghodnadi, Tal. Shirur, Dist. Pune on or before **19/06/2026**.
5. The Public Prosecutor shall be notified of the commitment of the case to the Hon'ble Court of Session, Ghodnadi, Tal. Shirur, Dist. Pune.
