ORDER BELOW EXH-1

01. This application is filed by the applicant for seeking interim custody of vehicle Ashok Leyland Company's Container bearing registration No. MH-01-AE-9773 having its chassis No.MB1A5EHD4MEJG2284 and engine No. MJEZ407875 seized in Cr.No.231/2026 of Ranjangaon (M.I.D.C.) Police Station.

02. It is the contention of the applicant that, seized vehicle is kept at Ranjangaon (M.I.D.C.) Police Station. The applicant requires the vehicle in his custody, as he is the owner of the seized vehicle. It is further contention of applicant that, if the seized vehicle will not be released, the engine and other parts of the vehicle will be damaged and its value will be diminished. Hence, it is prayed that, seized vehicle bearing registration No. MH-01-AE-9773 having its chassis No.MB1A5EHD4MEJG2284 and engine No. MJEZ407875 may kindly be released and handed over into the custody of the applicant as owner.

03. Say of A.P.P. and I.O. was called. The investigating officer has filed his say contended that if the seized vehicle handed over to the accused the possibility of committing same type of offence cannot be ruled out. Therefore, application may kindly be rejected.

04. The Ld. A.P.P. has filed his say on the application itself. He submitted that, after verifying documents of ownership appropriate order may kindly be passed.

04. Perused the record. Heard, the learned advocate appearing on behalf of the applicant. Applicant has relied on copy of R.C. Book of vehicle bearing registration No. MH-01-AE-9773 having its chassis No.MB1A5EHD4MEJG2284 and engine No. MJEZ407875 standing in the name of applicant. The applicant also submitted the copy of his Aadhar Card and copy of FIR.

05. The applicant has filed verified copy of R.C. Book of seized vehicle. This fact prima facie shows that, he is the owner of said vehicle. Hence, considering above mentioned fact and say filed by Ld.A.P.P, I am of the opinion that, applicant is entitled to the interim custody of the seized vehicle, as the possibility of damage to said vehicle can not be ruled out for want of its use in the custody of police. But, at the same time certain terms and conditions are required to be imposed while giving the interim custody of said Vehicle to the applicant, so that the said vehicle can be procured before court during course of trial. Hence, following order is passed.

:: ORDER ::

- 01.** The concerned Investigating Officer of Ranjangaon (M.I.D.C.) Police Station is directed that, vehicle Ashok Leyland Company's Container bearing registration No. MH-01-AE-9773 having its chassis No.MB1A5EHD4MEJG2284 and engine No. MJEZ407875 seized in Cr.No.231/2026, be handed over to the applicant Sachin Sudarshan Dev after furnishing Indemnity Bond of ₹ 10,00,000/- (₹ Ten Lac Only.) by the applicant, on his proper identification.

02. The applicant is directed to produce the seized vehicle in the Court as and when ordered by the Court, during course of trial and he is further directed not to change, alter, transfer or modify the said vehicle.
03. The applicant shall furnish Indemnity Bond in court and the verified copy of the same shall be submitted with concerned police station.
04. The Investigation Officer is directed to prepare proper detail Panchanama while handing over the interim custody of the seized vehicle and also to snap Colour Photographs of the same and submit the same as well as indemnity bond alongwith charge-sheet.
05. The Application is accordingly disposed of.
