:: JUDGMENT ::
(02/07/2026)

The accused is charged for the offence punishable under section 125 of the Bharatiya Nyaya Sanhita, 2023. The accused is produced before me. The particulars of offence was recorded and explained to him in vernacular. He has voluntarily pleaded guilty for the same.

As accused has pleaded guilty. I have explained to him he will not be entitled to any kind of compassion while awarding the punishment. Also he will not be entitled for any government benefits if any. Yet he has asserted that he has voluntarily accepting his guilt.

I come to conclusion that the accused has voluntarily pleaded guilty. **Resultantly I proceed to pass following order:**

:: ORDER ::

01. The accused is convicted for the offence punishable under section 125 of the Bharatiya Nyaya Sanhita, 2023 and to suffer imprisonment till rising of this court and sentenced to pay **fine of ₹ 1000/- (₹ One Thousand Only)** and in default to suffer simple imprisonment for 5 days.
