3. Thirdly, that you on the same date, time and place, caused grievous hurts to informant and his son such as to endanger human life or personal safety of others, and thereby committed an offence punishable under **Section 338 of the Indian Penal Code**, and within my cognizance.

4. Forthly, that you on the above date, time and place, committed mischief by causing loss or damage to Motorcycle No. MH-20/AX/7182 and Tata Tango Car No. MH-31/FI/9570 thereby committed an offence punishable under **Section 427 of the Indian Penal Code**, and within my cognizance.

5. Fourthly, that you on the above date, time and place, drove your above mentioned vehicle at a speed which was dangerous to the public having regard to all the circumstances of the place including a nature, condition and used of the place were the vehicle was driving and amount of traffic which was actually at the relevant time or which might reasonably be expected to be in the place and thereby committed an offence punishable under **Section 184 of the Motor Vehicles Act, 1988** and within my cognizance.

And I hereby direct that you be tried by me on the aforesaid charges.
