granted bail to applicants in Special Leave to Appeal (Crl.)  
No.3534/2025 dtd. 09/05/2025. Hence, the following order would  
meet the ends of justice.

ORDER

1. Application (Exh.3) is allowed.

2. **Applicants 1] Balasaheb Chandrakant Khaladkar, 2] Ganesh Balasaheb Khaladkar and 3] Shital Balasaheb Khaladkar** shall be released on bail on executing P. R. Bond in the sum of **Rs. 25,000/- each** with surety in the like amount in connection with C. R. No. 509 of 2024, registered with Khed police station, for the offences punishable under sections 324(4), 352, 351(2) r/w.3(5) of the Bharatiya Nyaya Sanhita and u/s.3(1)(r), 3(1)(S), 3(2)(va) and 6 of the SC & ST Act and 7(1)(D) of the Protection of Civil Rights Act.
3. The applicants shall not misuse liberty in any manner.
4. Applicants/accused shall not directly or indirectly make any inducement and/or influence and or pressurize or cause any threat or give any promise to anybody acquainted with the facts of accusations made against the applicants so as to dissuade such person from disclosing such facts to the court or to the investigating agency and shall not tamper in any manner whatsoever with the prosecution evidence whatsoever.
5. In the event any of the condition herein being violated, the prosecution would be at liberty to seek for cancellation of bail.
